Sir,  
With due respect, I beg to lodge a complaint against Rajen Singh S/O Baleswar Singh of New Prakash Nagar More, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri and about 40/50 others.

In this regard, I beg to report that on 23.09.2021 while performing K-37 Van Duty vide GDE No. 1153 Dated 23.09.2021 & MCC. No. 536/2021 Dated 23.09.2021, I along with force had been to New Prakash Nagar More for investigating Bhaktinagar PS Case No. 1225/2021 Dated 23.09.2021 U/S 341/325/427/379/506/34 IPC. At around 14.45 hrs, I along with force being accompanied by the complainant of the case Sri. Rajib Biswas S/O Lt. Bimal Biswas of Saman Nagar, PS Pradhan Nagar, Dist. Darjeeling reached at New Prakash Nagar More and proceeded to investigate the case. Meanwhile the FIR named accused of above referred case as mentioned above namely Rajen Singh S/O Baleswar Singh of New Prakash Nagar More, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri was found standing in front of a Saloon. The complainant identified the FIR named accused person and shown to us, then, I along with force proceeded towards him for investigation. When I informed him about allegations labelled against him and asked him actually what had happened, he became violent and started misbehaving with me and our Police team. I tried to convince him that we were there not to arrest him but to cause investigation, if needed Notice U/S 41 A Cr.P.C. would be served. He seemed in intoxicated condition as smell of liquor could be smelt from his breath. Then, he started shouting on the top of his voice, making hue and cry. Keeping due patience, I tried to calm him down, saying that I had visited the place to know the actual fact in the interest of the investigation of the case and not to arrest him. On hearing hue and cry, some locals also gathered there. Paying no heed to our request to calm down, he started dashing and pushing against us. I along with force tried to stop him but suddenly he assaulted my accompanying Constables namely; C/951 Netai Roy and C/710 Jiban Biswakarma with fists and blows on their chests and also with kicks, as a result they received pain and injuries on their persons. He dashed and pushed me, caught hold of my uniform and name plate and as soon as he got my name plate on his hand, he threw away the same. He assaulted me with fists and blows on my chest and body, as a result, I sustained injuries on my chest. I along with force somehow could bring him under control and tried to take him in Police Van. Meanwhile, some of his relatives did not allow taking him in Police Van. On seeing local resistance and our engagement in pacifying the locals, the alleged person Rajen Singh managed to escape from the spot. After informing duty officer, re-enforcement arrived at the spot and we could bring normalcy in the area. Then after, myself along with force medically treated at Siliguri District Hospital. Later on, one local brought my name plate at Police Station and handed over me.

Under the above circumstance, I request you that a specific case may kindly be started under proper sections of law against the above noted Rajen Singh S/O Baleswar Singh of New Prakash Nagar More, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri and about 40/50 others and arranged for proper investigation of the case.
