1 Sub-Inspector Srimanta Chatterjee of Bhaktinagar Police Station, Siliguri Police Commissionerate after producing one accused person namely Dibjoy Dey-26yrs s/o Ujjal Dey of Sholabigha Katabadi, Kasha ward No-1 Raiganj Dist Uttar Dinajpur at present Deshbandu Para, near Tarai School PS Siliguri Dist Darjeeling and seized total (1) 10 (Ten) bottles of Cefrex cough syrup each bottle containing 100 ML in which composition with chlorpheniramine Maleate 4 mg & Codeine phosphate 1P 10mg and Manufactured by SHIZAIN DRUGS AND PHARMACEUTICALS PVT LTD (2) 40 (Forty) Vials of DIAZEPAM INJECTION each vial containing 02 ML (3) 40 (Forty) Vials of PHENERGAN INJECTION each vial containing 02 ML (4) 40 (Forty) Vials LUPIGESIC INJECTION each vial containing 02 ML contained in a big plastic sack and kept in front place of one black colour Hero maestro scooty bearing No- WB74AD/2331) do hereby lodged written complaint to the effect that on 24,09.21 at 17.25 hrs received reliable source information that one person were standing near Market Complex, Haiderpara under Bhaktinagar PS with a Scooty loaded one big plastic sack in his vehicle contained illegal drugs (Injection & Cough syrup) to deliver the same to someone. It is reasonably believe that the person possessing the bag containing Injection & Cough syrup may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 1234 dated 24.09.21 and informed superiors about the plan of action. Thereafter myself along with ASI Dipak Karmakar, C/374 Debraj Biswas, CVF/935 Bipilab Roy, CVF/014 Labonnomoy Barman and CVF/619 Dharmendra Roy taking blank paper, wax, metal seal and knife and other kits left for Market Complex Halderpara to work out the information vide Bhaktinagar PS GDE No-1235 dated 24.09.21 & MCC No- 851/21 dated 24.09.21.

At 17.55 hours I along with officer and force reached near Market Complex, Haiderpara and contacted the source who show us the persons with the big plastic sack with one Scooty suspected to be contained cough syrup & Injection from a certain distance, I briefed all Officers and force to cordon the persons as tactful as possible in order to thwart their escape from the scene, Meanwhile I called two independent witnesses namely 1) Suraj Kumar Chhetri s/o Man Bahadur Chhetri of Ramchandra Nagar, ward no-42 PS Bhaktinagar Dist Jalpaiguri and (2) Jayanta Roy @ Chatu s/o Khirod Roy @ Khaitu of Pradhan More, South Ektiasal ward No-40 PS Bhaktinagar Dist Jalpaiguri after apprising them about the information received requested them in written to remain present with us during search and seizure. We rounded him up and questioned about his name and address when he disclosed his identity as above. On interrogation about the bag possessing by him, initially did not disclose anything about contains of plastic sack. I forced him to open it, when he disclosed that the bag contains injections & Cough syrup belongs to him. On further interrogation he disclosed that he procured the illegal cough syrup & Injections from Siliguri to deliver the same to another person. Then I detained him and gave an option in writing whether he is willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Gazette Police Officer. Then I informed Shri Amresh Singh, Inspector In-Charge, Bhaktinagar Police Station to come to Market Complex, Haiderpara requested him to presence during search and seizure of the injections & syrup.

At 18.25 hrs Shri Amaresh Singh, Inspector In-Charge, Bhaktinagar Police Station arrived at spot. Thereafter I opened the bag and found illegal injections & Cough syrup inside. I asked the accused

person above named to produce document if any in support of possessing such a huge quantity of injections & cough syrup with him but he failed to produce document. I seized the following articles under proper seizure list in presence of witness under direct supervision of IC Bhaktinagar PS under proper labeling. I informed Drug Controller Jalpaiguri over telephone requesting him to remain present at the spot but he failed to appear the PO.

NATURE OF ARTICLES SEIZED

- 1) 10 (Ten) bottles of Cefrex cough syrup each bottle containing 100 ML in which composition with chlorpheniramine Maleate 4 mg & Codeine phosphate 1P 10mg and Manufactured by SHIZAIN DRUGS AND PHARMACEUTICALS PVT LTD Marked as Exhibit-A out of one bottle taken as sample marked as Exhibit-A1
 - 2) 40 (Forty) Vials of DIAZEPAM INJECTION each vial containing 02 ML marked as Exhibit-B out of 02 vials taken as sample marked as Exhibit-BI
 - 3) 40 (Forty) Vials of PHENERGAN INJECTION each vial containing 02 ML marked as Exhibit-C out of 02 vials taken as sample marked as Exhibit-CI
 - 4) 40 (Forty) Vials LUPIGESIC INJECTION each vial containing 02 ML marked as Exhibit-D out of 02 vials taken as sample marked as Exhibit-DI
 - 5) One Black colour Hero maestro scooty bearing No- WB74AD/2331 (ALL THE ARTICLES CONTAINED IN A BIG PLASTIC SACK AND KEPT IN FRONT PLACE OF THE SCOOTY)

(Selzure was made in between on 24.09.21 in between 18.40 hrs to 19.20 hrs)

Under the above circumstances it is evident that the accused person above named procured has committing offence under NDPS act. On interrogation accused person confessed them guilt and stated that he was doing such kind of business illegally with any valid documents/License since long for his wrongful gain. It is crystal clear that the accused person is peddling prescription drugs meant for the sick people to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested him u/s 41 Cr.P.C. after explaining him about the ground of arrest issuing proper meme of arrest. Arrested accused person along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused person namely Dibjoy Dey-26yrs s/o Ujjal Dey of Sholabigha Katabadi, Kasba ward No-1 Raiganj Dist Uttar Dinajpur at present Deshbandu Para, near Tarai School PS Siliguri Dist Darjeeling and arrange for its investigation:
