Sir,

In producing herewith one accused person namely Gajen Barman (52) S/o Late Jatin Barman of Amtala Kankata More PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure.

(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 40 DP COUNTRY SPIRIT" each bottle containing 600 ML MRP Rs. 100/- (Total- 9 liter & Amount Rs 1500/-)

SI Pradip Kr Singha of Ashigar OP lodged a written complaint against the accused person namely Gajen Barman (52), S/O Late Jatin Barman of Amtala Kankata More PS Bhaktinagar Dist. Jalpaiguri in the effect that, on 24.09.2021 evening as per order of O/C Ashigar OP I along with ASI Izamamul Haque (J/377) Munna Ahmed and LV/1016 Amit Roy all of Ashigar OP with Govt. vehicle no WB32/R 8329 were holding raid against anti-social elements, warrentees, ID liquor etc in different area under Ashigar OP as per order vide Ashigar OP GDE no. 612 Dt 24.09.2021 in course of which I received information from my source that one Gajen Barman stored a huge numbers of bottles of liquor inside his house at Amtala Kankata More and used to sell to the local youth in higher rates. I immediately informed O/C Ashigar OP and as per his kind direction wasting no time I along with my accompanied party left for Amtala Kankata More area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/o Kalu Charan Ghosh of Ghogemali PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (31) S/o Hemu Sarkar of Strangon Nagar W/m- 36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Amtala Kankata More area as indicated by my source I held raid at the house Gajen Barman at Amtala Kankata More. But seeing as the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamah of the case, as the above noted per-obj as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.B Act. The Search and seizure and arrest were made in between 18.35 hrs and 19.55 hrs on 24.09.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Gajen Barman (52) S/O Late Jatin Barman of Amtala Kankata More PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
