In producing herewith one accused person namely Chabi Roy (51), S/O Jharu Roy of Fakdaibari PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure.

(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total- 9 Liter & Amount Rs 1500/-).

ASI Pradip Kr Singha of Ashigarh OP lodged a written complaint against the accused person namely Chabi Roy (51), S/O Jharu Roy of Fakdaibari PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 24.09.2021 evening as per order of O/C Ashigarh OP I along with ASI Inzamamul Hoque C/ 877 Munna Ahmed and UV/2016 Amrit Roy all of Ashigarh OP with Govt. vehicle no WB42/R 8829 were holding raid against anti-social elements, warrentees, ID liquor etc in different area under Ashigarh OP as per order vide Ashigarh OP GD no 612 D 24.09.2021 in course of which I received information from my source that one Chabi Roy stored a huge numbers of bottles of liquor inside his house at Fakdaibari and used to sell to the local youth in higher rates. I immediately informed O/C Ashigarh OP and as per his kind direction wasting no time I along with my accompanied party left for Fakdaibari area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghogomali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nagar W/no.36 PS Bhaktinagar Dist Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Fakdaibari area as indicated by my source I held raid at the house Chabi Roy at Fakdaibari. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and Seizure and arrest were made in between 16.55 hrs and 17.25 hrs on 24.09.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Chabi Roy (51), S/O Jharu Roy of Fakdaibari PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
