Dear Sir,

I, Smt. Anisha Sharma, wife of Sri Narendra Sharma, Principal, Delhi Public School, Siliguri, having its office at Delhi Public School, Dagapur, Darjeeling Road, Post Office and Police Station- Pradhan Nagar, District- Darjeeling, would like to inform you that amidst the pandemic we are providing online classes and online examination to our students. **Yesterday i.e. on 23.09.2021 at about 11 AM** when our Mid Term online Examination of Class XII Commerce Section D was going on, one unscrupulous person joined and created nuisance in the said online examination. It is relevant to mention here that we conduct our online classes and online examinations through ERP Software via Zoom (online) platform. Yesterday the said unscrupulous person entered in the online examination on numerous occasions as **"Manav Agarwal 12 D Commerce IP (Guest) vide IP address 47.11.25.243, "Manav Agarwal(Guest) vide IP address 223.239.51.126 and 223.239.57.81, "Manav Agarwal 12 D Commerce IP (Guest) vide IP address 49.37.51.164 and then under the disguise of "Dps Principal (Guest) vide IP Address 223.239.57.81** and after entering into our online examination he started abusing me and our Vice Principal with filthy languages which is not only detrimental as a Principal but also for the entire teaching fraternity. The said notorious person in front of all students and parents who were present at the relevant point of time in the online examination session commented vulgar languages like **"Baal cyber crime bhenchod sala ukaad h gandu anisha oor sukanto gandu sala ..... bhenchod sukanto ka laura.... laura lega bc..... batta h teko ham ... chutiya sukanto chutiya anisha sharma ..... Anisha sukanto ka laura legi".**

The said person deliberately and illegally commented such filthy, vulgar and defamatory languages which not only lowered the esteem of the school but also


I, therefore request your good self to look into the matter and book the culprit in accordance with appropriate provisions of law.
