Sir,

In producing herewith arrested accused person namely Rajesh Sahani (30) S/O Kamaldeb Sahani of Bagrakot, Chityaranjan Colony, Ward No. 18, PS-Siliguri, Dist- Darjeeling along with seized articles vize- i) 10 (Ten) sealed Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 10 =RS.1200/-) in which one sealed bottle has taken from mother packet box as sample , ii) 15 (fifteen) sealed Bottles of Himalayan Gold 60 up country spirit each containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 60 each ((Amounting of Rs 60/- x 15 =RS.900/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list.

I, SI Uday Chakraborty of Siliguri PS SPC do here by lodged a written complaint against above noted arrested accused person namely Rajesh Sahani (30) S/O Kamaldeb Sahani of Bagrakot, Chityaranjan Colony, Ward No. 18, PS-Siliguri, Dist- Darjeeling to the effect that on 24.09.21 at 15.55 hrs acting on secret information, I received a source information that the above noted person was busy to sale ld liquor illegally in his house situated at Bagrakot, Chityaranjan Colony, Ward No. 18 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1470 dated 24.09.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Siben Sarkar, ASI Subir Sen, LC/1313 Mili Roy, left for Bagrakot, Chityaranjan Colony, Ward No. 18 under Siliguri PS to verify the veracity of the information vide Siliguri PS G.D.E no. 1472 dated 24.09.21. On reaching at 16.15 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching - i) 10 (Ten) sealed

Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 10 =RS.1200/-) in which one sealed bottle has taken from mother packet box as sample, ii) 15 (fifteen) sealed Bottles of Himalayan Gold 60 up country spirit each containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 60 each ((Amounting of Rs 60/- x 15 =RS.900/-) in which one sealed bottle has taken from mother packet box as sample which was kept concealed in his house situated at Bagrakot, Chityaranjan Colony, Siliguri. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 16.25 hrs to 17.05 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I arrested him U/S-41 Cr.P.C after observing all sorts of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Rajesh Sahani (30) S/O Kamaldeb Sahani of Bagrakot, Chityaranjan Colony, Ward No. 18, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
