Sir,

In producing herewith one accused person namely Bilash Sahani-(45yrs.), S/O late Fakira Sahani of Santoshinagar, Machli Bazaar, Ward No. 5, PS- Siliguri, Dist- Darjeeling along with 14(forteen) bottles of Himalaya Gold 60up Country spirit each bottles containing 600 ml. & MRP Rs 100/- Talal RS. 1400/-

I SI Subhendu Das of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 24.09.2021 at 20:10 hrs. received an information from Shantoshi Nagar near Machhli Bazar, W/NO-05, PS-Siliguri, Dist- Darjeeling that one person has gathered huge quantity of illegal liquor which kept in his house which was kept in one gunny bag for selling the same in the open market for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO -902/21, Dated-24.09.2021. As per your kind instruction myself along with ASI Kala Chand Singha, C/ 1072 Anand Thakuri, C/ 239 Badal Barman and proceeded to the PO to work out the information. At 20:25 hrs. we reached at the Shantoshi Nagar near Machhli Bazar, W/NO-05 sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample. The seizure was made in between 20:40hrs. to 21:10hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Bilash Sahani-(45yrs.), S/O late Fakira Sahani of Santoshinagar, Machli Bazaar, Ward No. 5, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation.
