I, Sri Aktar Sardar (25), S/O Abdul Jabbar Sardar, Station Manager attached to Fulbarihat C.C.C under P.S NJP, District:- Jalpaiguri, empowered by the Electricity Act 2003 (Amendment Act 2007) do here by lodged this complaint against (1) Bhabash Mandal (50) S/O Lt Santosh Mandal of Village; Simulguri near ssk school PO.Kundardighi under P.S NJP for committing theft of electric energy U/S 135(1) (a) Electricity Act read with Amendment Act 2007 as stated here under.

On 24/09/2021 afternoon I accompanied by Staff, (1) Sri Ranjit Mandal (44), S/O Rabindra Nath Mandal designation Sub Assistant Engineer-1 (2) Suranjit Sarkar (36) S/O Late Paran Chandra Sarkar designation lineman attached to Fulbarihat C.C.C WBSEDCL and S&LP Team of Jalpaiguri Region hold raid and inspection at Village; Simulguri near ssk school PO.Kundardighi under P.S NJP . In course of inspection we had been to his premises of Bhabash Mandal (50) S/O Lt Santosh Mandal . He was not present at the time of inspection. In presence of his wife Sarasaty Mandal we started inspection, noticed P.V.C double core (red colour) wire was stretched to the service wire nearest LT line (Direct Hoocking) to his premises of Bhabash Mandal , this wire connected and fed power to two nos Ceiling Fan (60 watt) two nos LED bulb 40 watt. Bhabash Mandal committed power theft of U/S 135(1) (a) Electricity Act. I prepare inspection Memo at 15.15 hrs and disconnected electric connection and he has refused to put his sign at inspection copy.

Bhabash Mandal is a accused person who was committed theft of power of U/S 135(1)(a) Electricity Act. You are requested to take necessary action.
