Sir,

With due respect I beg to state that I Smt. Reena Raj wife of Shri Arbind Raj, residing at South Deshbandhupara near Kutimill gali, P.O. Bhaktinagar, P.S. New Jalpaiguri, Dist. Jalpaiguri lodged this written complain against the accused persons namely 1. Pankaj Chakraborty Son of not known residing at Bhaktinagar, near Chanachur Factory, P.O. Bhaktinagar, P.S. New Jalpaiguri, Dist. Jalpaiguri, 2. Ashim Paul Son of not known residing at Bhaktinagar, P.O. Bhaktinagar, P.S. New Jalpaiguri, Dist. Jalpaiguri, 3. Manik Paul Son of Late Badal Paul residing at "Purba Apartment", near Bibadi Sangha, Bhaktinagar, and one others.

That my husband Arbind Raj is the owner of land measuring 3 Katha situated within mouza, Khatian No. 392/1, Plot No. 347, P.S. Bhaktinagar, Dist. Jalpaiguri by virtue of registered deed of Sale being No. 4859 for the year 2012. That from last few months the above named accused persons threatened my husband that if he does not sell the aforesaid land in favour of them then they will grab our land illegally and forcefully. That yesterday on 24.9.2021 at about 5:50 PM they called my husband at Bibadi Sangha Club over telephone that there is some important talk about our landed property. When my husband went there, the above named accused persons mercilessly beaten my husband with hockey sticks and iron rod. Due to inhuman brutal torture of the accused persons my husband's nose and two teeth's was broken and he suffered severe injuries to his chest and every part of his body and due to this there has been lot of bleeding. Due to serious injuries immediately on 24/09/2021 my husband was admitted to New Jalpaiguri Railway Hospital and since he is there. In spite of that the accused persons did not restrain they continuously threatened my husband that if my husband does not sell the aforesaid land to them, then my will not stay in Siliguri they will kill my husband. Due to my husband's serious injuries today I came before you for your help and support.


Under the above circumstances, I would request you to take necessary action regarding that matter and punish the accused persons namely 1. Pankaj Chakraborty 2. Ashim Paul (M-8167528337) 3. Manik Paul and one other for their illegal acts and activities which will create pressure upon the health and mind of us otherwise we have no alternatives to survive.
