Sir, In Producing herewith one arrested accused Person namely Fatik Barman (male/43) sp. 14 Angson Barman as Const of Pally, Near Patai Patai Club, 57 NO-410, P.S. Baktianga, Dist Jalpaiguri along with seized articles (1) 10 (Ten) Bottles of 600 ml Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when Packed MRP Rs-100/- each (1) 01 (ONE) Nylon Bag which used for carrying the seized articles CL NO-01.

5. ASI. Gazi Bahaman of Panitanki TOP (under Siliguri P.S.) do hereby lodge a written complaint against the above noted accused Person to the effect that on 24.09.21 at 21.55 hrs during night while on duty I received report from informant that one Person is selling large quantity of Country Spirit of Serakh Road in Bagan, under Panitanki TOP. Accordingly of informant the informant to be Panitanki TOP and as per his direction I along with ASI Gazi Bahaman, CI 370 Bhanu Ch. Singh, CI-377 Dinesh Roy left for PO to work out the informant on arrival at Serakh Road, near in Bagan Siliguri at 06.55 hrs being pointed out by the source, found that one Person is proceeding with large quantity of Country Spirit containing with a Nylon Bag. I intercepted the said accused Person with loaded cartons in presence of witnesses. During interrogation the accused failed to produce any documents / license in support to the same and stated that he will give the same to the Const Pablu of Sub-Station Ch Pally. Near Patai Patai Club adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said Person with loaded cartons in presence of witnesses. On search I recovered (1) 10 (Ten) Bottles of 600 ml Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when Packed, MRP Rs-100/- each (1) 01 (ONE) Nylon bag which used for carrying the seized articles CL NO-01.

On interrogation he failed to produce any valid documents / license in support to the same and stated that he will give the same to the Const Pablu illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 10 (Ten) Bottles of 600 ml Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when Packed MRP Rs-100/- each (1) 01 (ONE) Nylon Bag which used for carrying the seized articles CL NO-01 under proper Seizen list and labeled the same in presence of witnesses and duly signing of them and also by the accused Person and arrested him. The seized also made between 07.15 hrs to 07.45 hrs and assessed the accused Person Rs-1000/- after examining charge against him, total value of seized articles is Rs-1000/-

Under the above circumstances I am submitting this written complaint against the above accused Person namely Fatik Barman (male/43) sp. 14 Angson Barman as Const of Pally, near Patai Patai Club, 57 NO-410, P.S. Baktianga Dist Jalpaiguri for starting a specific case under Proviso Section 139 of Law and amend for his investigation.
