Sub - Complaint/ FIR.

Sir,

I, MISS. PRIYANKA BARUA, Daughter of Late. Pannalal Barua, residing at Church Road, Near Shani Maharaj Mandir, within ward No. 10 of Siliguri Municipal Corporation, Post Office & Police Station - Siliguri, District - Darjeeling in the state of West Bengal would like to inform you that yesterday i.e., on 24.09.2021 early in the morning I was informed by van pullers of nearby transporter Radha Ballav Roadways that my LMV car bearing Registration No. WB/74/AF/5446 (Hyuandi I 20 Sports) which was parked beside my house was lying in a damaged condition like the front windshield was broken, the bonnet was badly damaged by boulder, the fog lamp was broken and there were number of scratches on the different parts of the body of the car.

Sir, CCTV footages in the nearby cameras might be helpful in ascertaining the wrong doers. I apprehend that the incident might have taken place between 2:00 AM to 5:00 AM of 24.09.2021.

It is pertinent to mention here that on 23.09.2021 there was conflict and hot altercations between me and my former tenant (1) Sri Sunil Kumar Shaw (2) Sri Vijay Kumar Shaw both sons of Late Phool Chandra Shaw along-with their Mother in front of my said premises wherein I was brutally manhandled and assaulted/ humiliated against which I have already lodged an FIR against them in the previous night so I apprehend that they might have their hands in this illegal act.

Your good office is therefore requested to lodge this complaint/FIR and immediately investigate the same and start criminal proceedings against the wrong doers and to put them behind the bars.
