Debapriya Malakar, daughter of Bidyut Malakar, resident of Baikuntapally, Anil Biswas Sarani, P.O.- Sevoke Road, Ward No. 41, Siliguri, P.S- Bhaktinagar, Dist- Jalpaiguri beg to state you that I was solemnized marriage with Biswajit Sarakar on 01/05/2016 according to Hindu rites and custom. After the marriage I was several occasions subjected to cruelty physically and mentally by my husband named Biswajit Sarkar.

That on 03/09/2021 when I was at my maternal home that time my husband Biswajit Sarkar, my Sister – in –law named Pinki Barman, her Husband Prakash Barman and my mother – in – law Bina Sarkar were entered in that house and physically assaulted me with using filthy languages and taken money from my house around of Rs. 20,000/- cash and told me to give divorce my husband or give huge amount of money if I don't give divorce or money then they will kill me.

That on 26/09/2021 at about 9:00 P.M when I along with my Grand Father and Grand mother making meal for dinner, at that time Anju Barman, Saraswati, Chanati, Kankila Roy along with another anti social women's were illegally trespass into my house with bamboo stick and other weapons and physically assaulted my Grand Father, my brother and me with the stick on my back and thereby I was fell down and immediately I was taken to Siliguri District Hospital.

Therefore I pray before you to take necessary legal steps against the above named accused persons as per law and would be pleased further to take to cognizance of the offences committed by the accused persons as per law.
