I, Sanjay Agarwal, S/O Rajendra Prasad Agarwal of Siddhi Vinayak Complex, Iskon Mandir Road, PS-Bhaktinagar, Dist-Jalpaiguri, West Bengal, would like to inform you that on 23.09.2021 at about 13.00 hrs, suddenly one Pawan Agarwal resident of 100 Pearls, Flat No- R1, PS-Bhaktinagar, Dist-Jalpaiguri came into my office at Chayanpara, Near Amtala Club, Salugara, PS-Bhaktinagar, Dist-Jalpaiguri forcefully and started to abuse me with filthy languages and on protest by me, they started to devastate chair and table of my office and unexpectedly Santu Agarwal threw a chair upon me as such I sustained several injuries on my body. They also threatened me with dire consequences. The entire incident has been recorded in the CCTV Camera of my office.

Therefore, I am requesting you to take appropriate legal action against the above named persons as per law. For this act I shall ever remain grateful and remain obliged for the same.
