like to inform you as follows: -

1) That I lodge this FIR to the effect that I got married  
to Ujjal Das, S/o Sitesh Das, Resident of Harihar Chandra pur,  
Barabanga, P.O. & P.S. Harihar Chandra pur, Dist. Malda, in  
the year 2011, subsequently the marriage was registered.

2) That after the time of my marriage, my husband, my  
mother & father in-law started to torture me for bringing  
down from my parental house and when I refused to  
bring down from my parental house my mother in-law  
namely Hanju Das, w/o Sitesh Das and my father in-law  
namely Sitesh Das, S/o Lt. Dhiren Das, started to beat  
me mercilessly and also throw boiled water upon me  
with an intention to burn my whole body.

3) That after year I gave birth to a male child namely  
Prityam Das, who is now 8 year old.

4) That after that my husband used to come home  
in a drunken condition almost every night, and  
started to beat me mercilessly at night and my  
mother & father in law abet my husband to kill  
me so that my husband can remain away.
