Subject: FIR.

Sir,

In producing herewith one accd person namely Achintya Mohanto(32) S/o Subhash Mohanto of Malipara, Talma, PS Kotowali Dist Jalpaiguri along with the seized vehicle bearing no WB 73B 7356 (white colour truk) under proper seizure list, I would like to state that today (i.e., on 24.09.2021) at about 11:25 hrs received an source information that a gang of vehicle lifter(thieve) plying a vehcle bearing no WB 73B 7356 (white colour truk) along NH 55, toward Darjeeling which did not have any valid documents and has been seen parking near Dagapur. Accordingly, diarized the matter in GD Pradhan Nagar PS vide GDE No. 1458 DT: 24.09.2021. I informed the matter to I/C Pradhan Nagar and as per his direction, I along with force left for Dagapur in government vehicle bearing no WB 74 AP 5359 vide DD GDE No 204, DT:24.09.2021.

On reaching near Dagapur, I contacted the source who indicated the place where the above noted vehicle was parked. We approached towards the place as per the indication of the source and saw that the vehicle mentioned by the source was parked in open space road side near Dagapur. We approached the vehicle and found one person inside the vehicle. On asking he tried to flee away left behind the vehicle but failed and we apprehended him. On interrogation he disclosed his name and address as noted above and on demand he failed to produce any valid documents in respect of the vehicle in his possession and also failed to produce valid driving license. On further interrogation of the apprehended person I have strong believe that the person stolen away and plying the vehicle. Accordingly, I seized the vehicle under proper seizure list duly signed by the witnesses seizure was made between 11:40 hrs to 12:10 hrs and arrested the above noted accused person u/s 41 CrPC.

Hence, I pray that a specific case may kindly be initiated against the above noted person and arrange for its investigation.
