- i) **21 (Twenty one) Bottles of Himalayan Gold Country Spirit 60'UP (each bottle contains 600 ml when packed)**


I P.S.I. Chetan Dangal of Pradhan Nagar P.S, SPC would like to lodge a written complainant against the above noted accused person to the effect that today on 24.09.21 at 14:05 hrs myself along with force ASI Ashit Singha, CV/223 Swapan Chettri, 646 Baban Das ,CV-128 Ajay Sahani ,242 Rakesh Manger, 645- Pankaj Gupta left from P.S for Special raid duty vide PDN P.S GDE NO 1469 24.09.21. During special duty I received an information that one person namely Rambilas Ray has stored huge quantity of illegal liquor in his shop situated at cooliepara, near Shiv Mandir, Ward no 01, P.S Pradhan Nagar, Dist-Darjeeling and selling the same from his house cum shop for illegal Gain. Accordingly I share the information to you and as per your kind instruction I along with force rush to the spot and hold raid in the house cum shop of the above noted person. On searching his house cum shop recovered above noted articles, and on demand he failed to produce any valid document in respect of the recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for illegal gain. Accordingly, I seized & label the above noted articles in between 21:15 hrs to 21:45 hrs and after that I arrested him at 21:50 hrs and brought to Pradhan Nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Rambilas Ray (M-55 yrs) S/O Lt. Thako Ray of cooliepara, near Shiv Mandir, Ward no 01, P.S Pradhan Nagar, Dist-Darjeeling and arrange for its investigation.
