After my marriage I was living with my husband at the above mention residence, after one month of my marriage my husband Rajesh Thakur, and my all in - laws family members namely

1. Father-in-law Ramesh Thakur,
2. Mother -in- law Asha Thakur, w/o Ramesh Thakur ,
3. Brother -in- law Prem Nath Thakur ,s/o Ramesh Thakur And

4. Sister- in - laws Mamta.thakur, d/o Ramesh Thakur and Pratima Thakur, d/o Ram Prawesh Thakur all are residence of Debidanga, Babu Basa, near Durga mandir they all were started torturing me mentally and physically and bitten me by fest and blows

I thought that may be gradually everything will be perfect but it's never changed and the torture level increases after birth of my daughter. Even no one was came to received me and my child in hospital when she born and my husband also demand 1 lack rupees from my parents as a dowry when I denied my husband and my in- laws were bitten me by fest and blows . and they also threatened me if my mother did not gave them the said amount they will killed me and also my daughter.

Therefore I, request to take a necessary legal step for me .
