Subject: Written Complaint against my husband and my in-laws and for commission of mental and physical torture and cruelty upon me.

Madam,

I, Smt Syamoli Singh @ Jadab, Wife of Mohan Jadab, Daughter of Sri Gour Singh, presently residing at Ujano, Sibnagar, P.O. & P.S. Matigara, Dist Darjeeling, do hereby lodge this Complaint against my husband Sri Mohan Jadab and my in-laws to the effect that I was married to Mohan Jadab, Son of Radha Jadab of Panchanadi, Matigara, P.O. & P.S. Matigara, Dist Darjeeling six years ago at my paternal house situated at Ujano, Sibnagar. That during the time of my marriage a sum of Rs. 2,00,000/- (Rupees Two Lakhs) in cash, including 3 Bhari (30 gram) gold and other gifts and ornaments were given to my husband and in-laws as per their demand. I belong to a very poor family but still my parents somehow managed to meet-up the demand of my husband and in-laws. That since the inception of marriage I was verbally and physically abused by my husband and in-laws on several occasions for want of more dowry. That abusing me and physically assaulting me was a daily routine of my husband and in-laws. I always kept my voice low and silently swallowed all the grief alone just to save my marriage.

Soon after the marriage I came to know that my husband is a habitual drunker and is a man of very violent nature. My husband used to come home at late night in a drunker condition and on many occasions he forceful penetrated upon me. I never informed my parents about the pain I was going through every day in my matrimonial house in order to save my marriage and believing that things might change and everything will be into peace. But the torture and assault upon me day by day exaggerated and it became unbearable. Finding no other alternative I informed my parents after one year of my marriage about all the physical and mental torture that my husband and in-laws were putting on me since my marriage.

That thereafter a meeting was held between parents of both the parties wherein Jhunu Bala the leader of Mahila Samiti was present, she along with other people present in the said meeting came up with a conclusion that I should rejoin the matrimonial house and my husband and in-laws promised that same things won't be repeated.

That soon after I went back one fine day the Dida (Nani) of my husband burned my hand with a burning fire stick I had burnt marks. That on several occasions my husband and my in-laws used to beat me up publicly with whatever they can and had even torn my clothes on many occasion.

That after 2 years of my marriage I became pregnant and delivered a baby boy named Harsh Jadab. That after the child came into my life I believed things might get normal as there was addition of happiness in our family. That nothing changed and I was again tortured physically and mentally by my in-laws i.e. my husband (Mohan Jadab), mother in-law, Grandmother (Nani @ Dida), sister-in-laws (Neha Jadab and Jyoti Jadab) and my brother-in-law (Bishnu Jadab). That torturing me was their daily habit and I had bruises on my body given by my husband and in-laws to which I had to weep and bare the pain all alone.

That last year during the time of Raksha Bandhan I was house arrested by my husband and his family members and they threatened to kill me by putting kerosene upon me and burning me but I somehow managed to flee away with my four years old child to my parental house situated at Ujano, Sibnagar. That I told in detail the entire incidence to my parents that had happened with me. That fearing threat to my life and to avoid any casualty in future to me and my child I did not return back to my matrimonial house. That on fine day approx. three to four months back my husband Mohan Jadab secretly managed to enter my parental house and he abducted my four years old child without my knowledge. That soon after the incident took place I somehow managed to contact him in order return my child back but he has blatantly refused to do so. That when my parents went to take back the child, my husband came up with Khukuri (a sharp object) and a bottle of acid and started shouting that he would throw acid on us and chop us with Khukuri if we even dare to go to his locality. I have been bed ridden since the said incident and I cannot stay alive without my minor son.

That I am in state of fear that my husband would cause any harm to my child as because in past he has already raised hand upon my minor child. That I always tried to swallow all the humiliations, tortures of my husband and his family members with a ray of hope that they all will change their behavior with efflux of time and sensing my minor son's future and looking after the ill health of my paralyzed father but day by day the inhuman torture upon me escalated which became unbearable by me. Now I have finally decided to avail the remedies provided under Law and I lodge this complaint before you with a hope of getting justice.

I humbly request to kindly enquire into the matter and initiate appropriate actions against the above named persons for the ends of justice.
