Respected Sir,

With due respect I the undersigned would like to inform you that I have lodged a complaint to the Officer-in-Charge Ashighar Out Post under Bhaktinagar Police Station on 28/10/2020 against my husband Sri Sanjit Dutta, S/o. Late Ananta Mohan Dutta and his family members.

I would like to further inform you that in the said complaint I have specifically mentioned that my husband tried to lift me forcibly on the way but somehow I managed to escape from there and rushed and entered into my house but he caught me from behind and he assaulted me and for that I fall down in front of my house and sustained head injury and I lost my conscious and thereafter I was admitted to Siliguri Sadar Hospital on 25/10/2020 and I was treated there for my head injury and after the treatment I was discharged on 27/10/2020. (copy of the discharge certificate dated 27/10/2020)

I would like to further inform you that as per my complaint dated 28/10/2020 the O.C. Ashighar Out Post under Bhaktinagar Police Station has started a case being Bhaktinagar P.S. Case No. 963/2020, U/s - 498A & 323 of I.P.C. but I failed to understand that why the concerned officer in charge and the investigating officer of the said case did not put the proper section against my husband regarding the said forceful act as stated above and the serious threatening by my husband to lift me forcibly and rape me by his men and persons and kill me and other serious act against me and my family members. (copy of the formal FIR and complaint is annexed herewith)

I would like to further inform you that my husband has been threatening me on the various pretext to withdraw the complaint otherwise he will give me a remarkable lesson to me, my brother and my aged father and he also told me that he is a police personnel (ASI UB/15) and the officer in charge of Ashighar Out Post under Bhaktinagar Police Station being his colleague will not take

proper and strict action against him so that I could not get the justice and thus my husband being a police personnel has been misusing his official power which is beyond his official duty and the said officer in charge and the investigating officer of the said case are also accommodating my husband most illegally.

Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.
