Sir

In producing herewith 05 (Five) arrested accused persons namely (1) Pintu Chatterjee (27) S/O-Lt Swapan Chatterjee of Jyoti Nagar (Near Chorak Math), ward No-04, PS Siliguri, Dist. Darjeeling, (2) Raja Sahani (19) s/o Sri Ranjit Sahani of Do, (3) Chandrika Singh (20) S/O Sri Kapil Singh of Do (4) Rohan Dutta (20) S/O- Lt Dipak Dutta of Lichu Bagan, Bagrakote, Ward No-18, PS Siliguri, Dist. Darjeeling and (5) Himu Ojha (24) S/O Manoj Ojha C/O Mahindra Singh of Bottol Company, (Near Councillor Office), Ward No-41, PS- Bhakti Nagar, Jalpaiguri along with seized articles i.e. (i) One iron knife measuring 12" including handle recovered from the possession of Pintu Chatterjee S/O-Lt Swapan Chatterjee (ii) one knife measuring 8" including handle along with one torch light recovered from the possession of Raja Sahani S/O Sri Ranjit Sahani (iii) One iron rod measuring approx 24" recovered from the possession of Chandrika Singh S/O Sri Kapil Singh, (iv) one iron rod measuring 14" recovered from the possession accused Rohan Dutta S/O- Lt Dipak Dutta and (v) One iron rod measuring approx 15 inch recovered from the possession accused Himu Ojha S/O Manoj Ojha under proper seizure list.

I, SI Rana Brahma of Panitanki TOP under Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint to the effect that on 30.09.2021 at 00:15 hrs myself received secret source information that approx 10/12 persons have assemble in a dark place beside Surya Sen Park, near Mahananda River bed with a view to commit dacoity at the locality. Immediately I informed the tip of information to I/C Siliguri PS and as per his kind direction I diarized the fact in GD book vide Panitanki TOP GDE No 692 Dated 30.09.2021. Accordingly myself along with SI Ashim Das, ASI Biswajit Ghosh, ASI Surajit Mallick, ASI Gazi Rahaman, C/370 Bharat Ch Roy and C/1036 Gopal Sribastav, left for spot to verify the veracity of the information. This refers Panitanki TOP MCC No 1492/21 dated 30/09/21 and GDE No 693 dated 30.09.2021. On the way I tried to call two independent witnesses but due to late night no independent witnesses could be found. At about 00-40 hrs I along with above noted police party arrived at the spot near a dark place beside Surya Sen Park, near Mahananda river bed and after keeping our vehicle at a distance place we proceeded towards Surya Sen Park on foot and being indicated by the source we noticed from the considerable distance that a gang of 10/12 persons have been assemble behind the dark place beside Surya Sen Park near Mahananda river bed and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of Police party, they scattered in multi direction and started fleeing away.

But after a hot chase we manage to apprehended 05 (Five) persons named (1) Pintu Chatterjee S/O-Lt Swapan Chatterjee (2) Raja Sahani s/o Sri Ranjit Sahani (3) Chandrika Singh S/O Sri Kapil Singh (4) Rohan Dutta S/O- Lt Dipak Dutta and (5) Himu Ojha S/O Manoj Ojha. On interrogation, the apprehended persons disclosed their name and address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further interogation they stated that they along with others were assembled there in preparation to commit dacoity. Accordingly on the spot and on being search in presence of witnesses I recovered from the apprehended persons the following articles i.e (i) One iron knife measuring 12" including handle recovered from the possession of Pintu Chatterjee S/O-Lt Swapan Chatterjee

(ii) one knife measuring 8" including handle along with one torch light recovered from the possession of Raja Sahani S/O Sri Ranjit Sahani (iii) One iron rod measuring approx 24" recovered from the possession of Chandrika Singh S/O Sri Kapil Singh, (iv) one iron rod measuring 14" recovered from the possession accused Rohan Dutta S/O- Lt Dipak Dutta and (v) One iron rod measuring approx 15 inch recovered from the possession accused Himu Ojha S/O Manoj Ojha. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly signed by them in between 01:05 hrs to 01:45 hrs and I arrested them U/S 41 Cr.P.C after explaining the charges against them.

Under the above fact and circumstances I pray that a specific case may kindly be started against (1) Pintu Chatterjee S/O-Lt Swapan Chatterjee (2) Raja Sahani S/O Sri Ranjit Sahani (3) Chandrika Singh S/O Sri Kapil Singh (4) Rohan Dutta S/O- Lt Dipak Dutta and (5) Himu Ojha S/O Manoj Ojha, along with seized articles as mentioned above under proper section of law.
