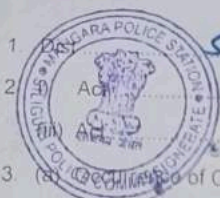

Sir

With due respect I, Smt. Jayanti Chaki w/o Sri Subhashish Chaki resident of Flat No. 1/E "RAINBOW HILL" Purba Sarada Pally, near Balason Society (Road between Phansidewa More to Kadamtala), Shiv Mandir, Ps-Matigara, Dist-Darjeeling Pin-734011 and also a member of Animal Help Line, Siliguri do hereby lodge this complaint against the resident of Flat No. 3/A of same apartment namely Nazimul Islam Chowdhury and another unknown to that effect that the said persons since occupancy of his flat for two is against the pet dogs and started quarrelling over the issue. In this regard I would to report that I have a pet (German shepherd) and also two adopted female dogs of Indian Species which were residing in the said residential area since long. These two female dogs were under treatment because of their ill health and were undergone medical surgery recently. The said pets were residing in the garage allotted against me in the ground floor and with the consent of the promoter and other flat members. But the said Nzimul Islam Chowdhury and his wife picked up quarrel over the said issue and trying to oust the said two poor pets from the residential area putting some false allegations. Not only this, the said Nazimul Islam Chowdhury and his wife picked up a quarrel on 28.07.2021 with me in presence of my son and threatened to kill the dogs and to do harm to myself. He used vulgar languages towards me which amounts to outrage of my modesty. During quarrel he stated he will disrobe me and will kill me by electric shock by hiring professional criminals from Malda as he belongs to Kaliachawk, Malda. He stated all these things in presence of my son and night care taker Ashish Aley. If my son and care taker Ashish Aley would not be there they would definitely assault me physically. Being terrified by the said violent attitude of Nazimul Islam Chowdhury and his wife myself informed my husband about the incident who accordingly informed your good office for police assistance as they were in a violent mood and tried to throw chair upon me.

On 22.09.2021 I along with all family members went to Alipuduar for urgent work leaving my two sick adopted Pets under care of care takers namely Sonu Lama and Sushil Saha arranging food as I had a strong doubt that the person Nazimul Islam Chowdhury may cause harm to them taking advantage of my absence. On 22.09.2021 evening care taker Sonu Lama informed me that both the dogs are missing. I immediately informed the matter to Smt. Priya Rudra of Animal Help Line Siliguri who immediately made contact with the said Nazimul Islam Chowdhury and enquired about the sudden disappearance of the dogs. I cut short my tour and returned to my flat at Shiv Mandir, Siliguri. After seeing the CCTV footage installed in the apartment it came to light that the said Nazimul Islam Chowdhury on 22.09.2021 tried to catch hold the said pets in the morning by chasing them but failed. In the evening it has found from the CCTV footage that he along with another unknown who is not a member of any residential flat of "RAINBOW HILL" covered the camera with cloth and went to the place where the dogs usually sleep and left the premise by driving his vehicle bearing No WB74 AQ/2270. I have a strong doubt that this animal hater killed one of the pets and dispatched her body in the vehicle and thrown it somewhere. It has also found that they are putting something inside the vehicle thereafter washing the floor most probably to remove the stain of blood and threw one heavy stone like object towards the backside boundary wall. Later the night guard Sonu Lama found that one of the cameras is in hanging condition and the said Nazimul Islam Chowdhury trying to fix it in its original position. The evidence of his criminal activity is clearly reflected in the CCTV footage. After we started checking the CCTV footage the said Nazimul Islam Chowdhury disappeared from his flat.

Hence, in this perspective I request you to take a strong action against Nazimul Islam Chowdhury and his associate for their cruel activity towards my adopted pets and brutally killing one of them and for outraging my modesty.
