Sir,

In producing herewith one arrested accused person namely Binod Paswan (50) s/o Lt Debu Paswan of Bedgera, near Navin Sangha Club, P.O Salugara, PS Bhaktinagar, Jalpaiguri along with following seized articles as per proper seizure list:

1. Twenty Four (24) bottles of Kingfisher Strong premium beer each bottle containing 650 ml (Total 15.6 Ltrs)

I, PSI Sailesh Subba of Bhaktinagar PS, SPC would like to lodge a written complainant against the above noted arrested accused person to the effect that on 01.10.2021 at 14.15 Hrs received a source information that one Binod Paswan of Salugara was standing at Sevoke Road, near Akshyatar Apartment, under Bhaktinagar PS, possessing huge amount of liquor inside plastic bag for selling the same to the customer for his wrongful gain. This refers to Bhaktinagar PS GDE No-26 Dated 01.10.2021. Accordingly, I informed I/C Bhaktinagar PS/SPC about the information. As per his kind instruction, I along with ASI Rabin Lama, CVF/619 Dharmendra Roy, CVF/614 Sumit Kumar Roy headed towards Prakash nagar to work out the information. At 14.30 hrs we reached at the spot, and after being identified by the source I along with force apprehend said person and on intervention he disclosed his identity as Binod Paswan (50) s/o Lt Debu Paswan of Bedgera, near Navin Sangha Club, P.O Salugara, PS Bhaktinagar, Jalpaiguri. On being search recovered the above noted seized articles from his possession. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses namely CVF/614 Sumit Kumar Roy and CVF/619 Dharmendra Roy both of Bhaktinagar PS/SPC undersigned of seizure list. The seizure was made between 14.45 hrs to 15.05 hrs. I, arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I, therefore request you to kindly register a specific case against the accused person namely Binod Paswan (50) s/o Lt Debu Paswan of Bedgera, near Navin Sangha Club, P.O Salugara, PS Bhaktinagar, Jalpaiguri under proper section of law.
