In producing herewith one accused person namely Pranab Das (42), S/O-Late Srimanta Das of Near Ambedkar Club, Niranjana Nagar PS Bhaktinagar Dist. Jalpaiguri, Permanent address- Nayabazar no-1 More PS Gangarampur Dist. Dakshin Dinajpur and the following articles under seizure:

- (1) 15 (fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total- 9 Liter & Amount Rs 1500/-).

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Pranab Das (42), S/O-Late Srimanta Das of Near Ambedkar Club, Niranjana Nagar PS Bhaktinagar Dist. Jalpaiguri, Permanent address- Nayabazar no-1 More PS Gangarampur Dist. Dakshin Dinajpur to the effect that, on 01.10.2021 evening as per order of O/C Ashighar OP I along with ASI Krishna Ch Singha C/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no.15 Dt 01.10.2021 in course of which I received information from my source that one Pranab Das stored a huge numbers of bottles of liquor inside his house Near Ambedkar Club, Niranjana Nagar and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Near Ambedkar Club, Niranjana Nagar area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghogomali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching Near Ambedkar Club, Niranjana Nagar area as indicated by my source I held raid at the house Pranab Das Near Ambedkar Club, Niranjana Nagar But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 19.05 hrs and 19.25 hrs on 01.10.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Pranab Das (42), S/O-Late Srimanta Das of Near Ambedkar Club, Niranjana Nagar PS Bhaktinagar Dist. Jalpaiguri, Permanent address- Nayabazar no-1 More PS Gangarampur Dist. Dakshin Dinajpur and arrange for its investigation.
