Sir,

In producing herewith one arrested accused person namely Paban Saha (M-30) S/O- Sri Gopal Saha of-Durgadas Colony, W/No-18, PS Siliguri, Darjeeling along with seized articles (1) 18(Eighteen) Bottles of 60 UP Country Spirit styled as PET HIMALAYAN GOLD Country Sprit of 300 ml each when packed, MRP Rs. 60/- each 2) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1.

I, SI Arindam Chatterjee of Panitanki TOP under Siliguri PS herby lodge a written complaint against the above noted accused person to the effect that on 01.10.21 at 18.45 hrs during spl raid duty received secret source information that one person is carrying huge quantity of bottle country spirit through Mahakalpally road, near Suryasen Park and proceeded towards Durgadas Colony, W/No-18. Accordingly informed to OC Panitanki TOP and as per his direction I along with, ASI Manu Dey, C/114 Naresh Hasda and CV/1009 Manoj Thakur, left for Mahakalpally road to work out the information. On arrival at Mahakalpally road, near Suryasen Park, at 19:10 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of Police witnesses. On interrogation the accused person disclosed his name and address as Paban Saha (M-30) S/O-Sri Gopal Saha of-Durgadas Colony, W/No-18, PS Siliguri, Darjeeling. He also failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Durgadas Colony, Siliguri adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 18(Eighteen) Bottles of 60 UP Country Spirit styled as PET HIMALAYAN GOLD of 300 ml each when packed, MRP Rs. 60/- each 2) 01 (One) Nylon Bag which used for carrying the seized articles SI No- 1, under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 19:35 hrs to 19:55 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs.1080/-
