Respected Sir

I, Sri Nikunj Agarwal, Son of Ravi Agarwal, Partner of M/s R.R.S. Enterprise, residing at SP Mukherjee Road, Siliguri, Post Office - Siliguri Bazar, Police Station - Siliguri, District - Darjeeling, PIN - 734005, in utmost torment, do hereby state before you the outrageous happenings that occurred on the night of 24.09.2021.

1. Be it mentioned that, M/s R.R.S. Enterprise became the sole, absolute and exclusive owner of all that piece or parcel of land measuring 1.66 Acres, behind Bandhunagar School, forming part of R.S. Plot No.93 recorded in R.S. Khatian Nos.10/1, 10/2, 10/3 and 10/4, situated within Mouza - Ambari Falakat, J.L. No.22, District - Jalpaiguri by virtue of registered Sale Deed and since the said date of purchase, M/s R.R.S. Enterprise has been exercising and enjoying all unfettered rights of title, ownership and possession over the said land.

2. Be it further mentioned that since the day of purchase, one Md. Mazrul (since deceased) use to take care of the said land and after his death, his widow - Rafia Khatun was appointed as the caretaker of the said land.

3. Now, in severe anguish, I brief you with the horrors of the night of 24.09.2021. That one Sahidul Mohammad, one Md. Farid, one MD. SHIRAJ together with their men and associates, without any lawful authority, in collusion with each other and forming an unlawful assembly, trespassed into the aforesaid land well equipped with sticks and combustible substances.
