JH02AA1237 for carrying Tea from our godown Sahudangi to Kolkata. We loaded 689 packet of tea, the weight of this goods is 20948.7 KGS. The name of the driver is Anurag Saw, mobile number is 7091240305 and the vehicle chassis number is MAT466388D1JX5398 and Engine number is B59180323J633D3322. The licence number of driver is JH12 20100015101. The owner of this vehicle is Kapil Prajapati, son of Kamlesh Prajapati, resident of Hajaribag.

That after loading of the tea in the said vehicle is not reach at Kolkata till today. We did not receive any whereabouts of this vehicle also till now. The mobile of the driver and owner is still switch off.

Sir, I apprehended that the driver in collusion with the owner misappropriate the goods (Tea) or theft the goods which was duly entrusted to the driver and the owner of this vehicle.

Under this circumstances I humbly pray to recover my tea from the culprits and take legal action as per law and punished them as per law.
