I, PSI Kalyan Saha of Pradhanagar PS SPC do here by lodged a written complaint against arrested persons named 1)Balram Sah(55) s/o Lt Jagindar Sah of Champasari Pokajote PS Pradhanagar Dist Darjeeling 2)Raja Ram Sah(23) s/o Balram Sah of Champasari Pokajote PS Pradhanagar Dist Darjeeling . In this regard I -beg to report that on 29 09.21 while ASI Tarun Kanti Ghosh along with force were engaged in L/O duty at Sri Guru Vidyalaya for Covid-19 Vaccination. At around 15:00 hrs time some persons were creating hulla and nuisance and they also abusing our police party in filthy language and pushed the police party as they have not get their vaccine today. ASI Tarun Kanti Ghosh tried to specify them and requested to not to do the same but they started abusing him. Accordingly ASI Tarun Kanti Ghosh was informed the matter to Inspector In Charge, Pradhanagar PS ,SPC for re enforcement. Subsequently as per order of I/C Pradhanagar PS myself along with Const-974 Mintu Sen, Const-880 Shyamal Dutta rushed to the spot. On reaching there I also tried to convince them and requested them to left the place. But they did not hidden my word and also assaulted myself and our police party with fist and blows and kicks. Finding no other alternative way I arrested above noted persons from the spot.

So, I pray to your kind honour that a specific case may kindly be started against the arrested persons named 1)Balram Sah(55) s/o Lt Jagindar Sah of Champasari Pokajote PS Pradhanagar Dist Darjeeling 2)Raja Ram Sah(23) s/o Balram Sah of Champasari Pokajote PS Pradhanagar Dist Darjeeling who were disturbing on duty police and assaulted police party and arrange for its investigation.
