highlight the matter of numerous incidents of

Saw. The violence started almost two months
ago from the present date, where ~~be~~ my husband
intoxicated from alcohol continuously gave physical
and mental hurt to me and my son Rakesh
Prasad Saw. My husband on numerous occasions
gave hurt and physical abuse to me and
also threatens ~~me~~ to kill me. My husband
on 1st October 2021, also kicked me and threw
stones on my son. The above ~~said~~ mentioned
scenario has repeated quite a few times
in past two months

This matter has subjected to the degradation of my health both physical and mental. My husband from past two months committed domestic violence by hitting me -

- Kicked me on my face.

- Threw stones on me and my son.

- Tried hitting me from a stick.

- Pulled my hairs and beat me from various objects.

- Used numerous bad words and abused me and my family.

- Threatens me by calling from various numbers.

- Also tries to throw me out of the house.

Therefore I kindly request to lodge an FIR on this subject matter and take possible action against my husband.
