Sir,

In producing herewith the accused persons namely (1) Koushik Das @ Papai Das (22 yrs), S/O Nirmal Das of Mukta Mancha W/no. 02 PS Pradhan Nagar Dist. Darjeeling and (2) Shibu Sarkar(22) S/O Rashu Sarkar of Dhaknikata Champasari PS Pradhan Nagar Dist. Darjeeling and following seized articles as noted below ----

- i. One (01) prohibited fire arms Auto Pystal Made in USA, 9MM ,which total length is 20.6 CM, Butt partial wooden measuring 9.6 CM, body measuring 6.7 CM and barrel measuring 10 CM & Magzine measuring length 11.5 CM , loaded with two (02) live ammution which are marked as KF 04,9MM2Z on percution cap recovered from the waist of accused Kaushik Das @ Papai Das.
- ii. (2) Two numbers of live ammution which are marked as KF 04,9MM2Z and KF 09,9MM2Z from the pocket of full pant of accused Shibu Sarkar
- iii. (1)One vehicle bearing registertion no. WB73/E 7512
- iv. (2) Two numbers of mobile phone one VIVO,IMEI NO.869473049471096 & IMEI no. 869473049471088 and another is REDMI ,IMEI no. 868559045205115 & IMEI no. 868559045205123

I ASI Krishna Singha of Ashighar OP beg to lodge this written complaint against the above noted arrested accused persons to the effect that today on 02.10.2021 at 21.25 hrs. I along with C/ 181 Bhobesh Ch Roy , C/877 Munna Ahmed, and CV/1034 Manojit Barman all of Ashighar OP performing Naka Cheeking duty at Ashighar more vide Ashighar OP GDE no. 37 Dt. 02.10.2021. In course of which I received a reliable source information that two persons coming from NJP side by a four wheeler Car having Automatic fire arms and ammution and who are supposed to sale it to some other persons clandestinely. The dealing of fire arms will be made at Baneshwar More , Eastern Bypass and they will go to Baneshwar More via Ashighar more. Accordingly I informed the matter to O/C Ashighar OP . As directed by O/C Ashighar OP. myself along with my officer & force ambushed at Ashighar More to work out the information at 21.35 hrs . At 21.45 hrs we called to local respectable persons and disclosed our motto to (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghogomali Niranjan Nagar PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (32) S/O Sunil Sarkar of Badurbagan PS Bhaktinagar Dist. Jalpaiguri. I requested them to accompany us to witness, Search and seizure if any made . They agreed and accompanied us. At about 21.55 hrs. found two young persons arrived at Ashighar More with four wheeler vehicle bearing no. WB73/E 7512. We gradually proceeded nearer to them but seeing us the said persons tried to flee away from the spot with their vehicle no WB73/E 7512, but somehow we managed to detain them with vehicle .On search we found One (01)prohibited fire arms Auto Pystal Made in USA,9MM ,which total length is 20.6 CM,

Butt partial wooden measuring 9.6 CM, body measuring 6.7 CM and barrel measuring 10 CM & Magazine measuring length 11.5 CM, loaded with two (02) live ammunition which are marked as KF 04,9MM2Z on percussion cap recovered from the waist of accused Kaushik Das @ Papai Das. (2) Two numbers of live ammunition which are marked as KF 04,9MM2Z and KF 09,9MM2Z recovered from the pocket of full pant of accused Shibu Sarkar (3) One vehicle bearing registration no. WB73/E 7512 (4) Two numbers of mobile phone one VIVO IMEI NO.869473049471096 & IMEI no. 869473049471088 and another is REDMI, IMEI no. 868559045205115 & IMEI no. 868559045205123. On being demanded by me they failed to produce any valid documents for possessing such fire arms and ammunition. Accordingly, I seized the same as alamt under proper memo of seizure duly authenticated by the witnesses and took into custody. I also arrested the said persons who disclosed their name and identity as noted above. The search, seizure and arrest were made in between 22.05 hrs. to 22:35 hrs. I also prepared label for the fire arms and ammunitions.

Under the above noted circumstances, I pray, a specific case against the above noted accused persons may kindly be started under proper section of law and arrange for its investigation.
