In producing herewith two accused persons namely (1) Ramji Prasad Bhagat (33 year) s/o Arjun Prasad Bhagat c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Lall Bazar MW, Singtam Nagar Panchayat Aritar(dung dung), Linzey East Sikkim (2) Aruna Rai w/o Late. Padam Chettri c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Near Champa Maya School, Lamini Gaon, Bhalukhop, PS Kalimpong, Dist. Kalimpong after proper arrest U/S 41 Cr.P.C and the following properties under seizure -

1] 138 (One Hundred and Thirty Eight) grams of brown colored powder Said to be Brown Sugar packed in a transperant plastic pouch marked as "Exhibit A" out of which 05 gram brown coloured powder Said to be Brown Sugar is taken as sample from "Exhibit A" and marked as "Exhibit A-1".

2] 125 (One Hundred and Twenty Five) grams of brown colored powder Said to be Brown Sugar packed in a transperant plastic pouch marked as " Exhibit B" out of which 05 grams brown coloured powder Said to be Brown Sugar is taken as sample from "Exhibit B" and marked as "Exhibit B-1".

3] 02 (Two) pieces of Silver Coloured Digital Pocket Weighing Machine.
Seized the above noted articles from the rented house of accused (1) Ramji Prasad Bhagat (33 year) s/o Arjun Prasad Bhagat c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Lall Bazar MW, Singtam Nagar Panchayat Aritar(dung dung), Linzey East Sikkim (2) Aruna Rai w/o Late. Padam Chettri c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Near Champa Maya School, Lamini Gaon, Bhalukhop, PS Kalimpong, Dist. Kalimpong

I, PSI Sailesh Subba of Bhaktinagar PS/SPC do hereby lodge a written complaint against the above noted arrested accused person to the effect that on 02.10.2021 at around 14.45 Hrs received a secret source information that one person namely Ramji along with his female associate is possessing huge amount of contraband powder said to be Brown Sugar at his rented house at Shib nagar, under Bhaktinagar PS. Accordingly, I diarized the matter vide Bhaktinagar PS G.D.E. No. 99, Date. 02.10.2021 and informed the matter to Inspector in Charge, Bhaktinagar PS/SPC. As per his kind instruction at around 14.55 Hrs myself along with SI Srimanta Chatterjee, ASI Deepak Karmakar, LC/1248 Puja Tamang, LC/1233 Jaytika Roy CVF/014 Labanyamoy Barman, CVF/619 Dharmendra Roy and CVF/935 Biplab Roy all of Bhaktinagar PS/SPC left for Shibnagar under Bhaktinagar PS/SPC vide Bhaktinagar PS MCC No. 947/21 DT.02.10.2021 to verify the veracity of the information. At around 15.15 Hrs I along with force reached at Shibnagar and as shown by the source cordoned said house from all sides to prevent escape of accused persons. I then along with remaining force entered into the compound of the house and called the owner of the house namely 1] Sandhya Roy w/o Mohan Roy of Shibnagar, Beside Balaji Complex Apartment, P.O. Salugara, PS Bhaktinagar, Dist Jalpaiguri and two local independent witness namely 2] Pinki Barman

Salugara, PS Bhaktinagar, Dist Jalpaiguri 3] Anjali Roy w/o Rabindra Roy of of Shibnagar, Beside Balaji Complex Apartment, P.O. Salugara, PS Bhaktinagar, Dist Jalpaiguri and informed them about the information and served notice to them in written to accompany the Police during search and seizure if necessary. They agreed to co-operate with Police and at about 15. 30 Hrs as shown and identified by the source and witnesses I, entered the rented house of Ramji and on entering found one Lady and a person were preparing for packeting of some articles using polythene and digital pocket weighing machine. On seeing us both of them became nervous and tried to hide the articles which they were possessing. I disclosed my identity as Police Officer and also my accompanying Police team and detained both of them. On intervention they disclosed their identity as (1) Ramji Prasad Bhagat (33 year) s/o Arjun Prasad Bhagat c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Lall Bazar MW, Singtam Nagar Panchayat Aritar (Dung Dung), Linzey East Sikkim (2) Aruna Rai w/o Late. Paulam Chettri c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Near Champa Maya School, Lamini Gaon, Bhalukhop, PS Kalimpong, Dist. Kalimpong. On further interrogation, they admitted that they were possessing, and preparing to make a pouch of Brown Sugar for selling the same to the local drug addicts of Siliguri for their wrongful gain. Their admission arose strong reason to believe that the above noted person illegally possessed and stored the prohibited Brown Sugar at his house. I gave him option notice that whether he wanted to be searched in presence of Executive Magistrate or Gazetted Officer and he agreed in writing that he did not have any objection if the search be made in presence of Gazetted Officer. Then, I requested Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station over Telephone to be present at the P.O. for the purpose of search and seizure informing the whole fact.

At 16.05 hrs Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station arrived at the P.O. and disclosed his identity to the accused persons as Inspector In-Charge of Bhaktinagar Police Station under Siliguri Police Commissionerate and that he is Gazetted Officer. Thereafter, following the formalities of search and seizure in presence Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station and the above noted three witnesses search the person of each Police personnel of our team and nothing could be found except service fire arms and wearing apparel. Then searched detained person found nothing except wearing apparel. Then, in presence and supervision of Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station and two disinterested witnesses searched the house of detained persons and after long interval of search found two packet of brown coloured powder packed in polythene bag inside the Box made up of Tin. In presence of Gazetted officer and witnesses and Police Party demanded them valid papers / documents of brown powder said to be Brown Sugar but they failed to produce the same. Accordingly, in presence and supervision of Gazetted Officer Sri Amaresh Singh, Inspector of Police, Bhaktinagar Police Station and in presence of witnesses sealed the transparent polythene pouch and labelled and marked.

NATURE OF ARTICLES SEIZED

1] 138 (One Hundred and Thirty Eight) grams of brown coloured powder Said to be Brown Sugar packed in a transparent plastic pouch marked as "Exhibit A" out of which 05 gram brown coloured powder Said to be Brown Sugar is taken as sample from "Exhibit A" and marked as "Exhibit A-1".

2] 125 (One Hundred and Twenty Five) grams of brown coloured powder Said to be Brown Sugar packed in a transparent plastic pouch marked as "Exhibit B" out of which 05 grams

3) 03 (Three) pieces of Silver Coloured Digital Pocket Weighing Machine

The seizure was made in between 16:35 hrs to 17:25 hrs and arrested them U/S 41 Cr.P.C informing them their ground of arrest.

Under the above circumstances it is evident that the accused persons above named procured has committed offence under NDPS Act of 1985. On interrogation accused persons confessed their guilt and stated that they are doing such kind of business illegally with any valid documents/License since long for their wrongful gain. It is crystal clear that the accused persons was peddling illegally such drugs meant for the sick people to cater to the need of drugs abusers in the locality which has become menace to the life of the young generation and perishing the home of thousand parents and violated the provision of Narcotics Drugs and Psychotropic Substances Act and liable for punishment.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Ramji Prasad Bhagat (33 year) s/o Arjun Prasad Bhagat c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Lall Bazar MW, Singtam Nagar Panchayat Aritar(dung), Linzey East Sikkim (2) Aruna Rai w/o Late. Padam Chettri c/o Mohan Roy of Shibnagar, PO Salugara, P.S Bhaktinagar, Dist Jalpaiguri, P/A. Near Champa Maya School, Lamini Gaon, Bhalukhop, PS Kalimpong, Dist. Kalimpong and arrange for its investigation.
