Respected Sir,

With due respect I, Smt. Sujata Xalxo, W/o. Sri. Edwin Toppo, resident of Jhauguri, P.O. New Chamta, P.S. Matigara, Dist. Darjeeling beg to state that I belongs to Schedule Tribe community. I along with my husband and children are residing in a house constructed over 10(ten) decimals land situated within Jhauguri Mouza, under L.R. Plot No. 355. In the said house we have also electric connection in the name of my father-in-law James Toppo. My husband is also paying panchayat taxes to the Gram Panchayat in respect of our said house. Since the year of 1985, my husband and our other family members are residing thereon.

That one Md. Rajab Ali, S/o. Md. Tamijuddin@Abdul Majid, resident of Damra Gram, P.O. Gulma, P.S. Pradhannagar, Dist. Darjeeling has been threatening my husband since last one month that he will capture our house and land. MD. Rajab Ali claimed as owner of our house by showing a deed of sale being no.1-6120 for the year of 2009. When we have verified the said deed, we found that in the said deed, L.R. Plot No. 355. is not mentioned, but by misleading the BLLRO, he has recorded his name in the said Plot of land. Md. Rajab Ali has also filed a civil suit being T.S. No. 164/2021 against my husband and our other family members. After knowing the civil suit, my husband has appeared before the court and ready to contest the case. But in the meantime, when said Rajab Ali found that he will not win the case, on 24.09.2021, he along with his associates namely Bijoy Sha, S/o. Late Khelawan Sha, resident of Salbari, P.S. Pradhannagar, Dist. Darjeeling and Sri. Hira Sahani, S/o. Madan Sahani, resident of Jhauguri, P.S. Matigara, Dist. Darjeeling altogether came to our house and they have started to assault my husband by fist and blows asking us to quit and vacate the house immediately. When I have tried to save my husband, Bijoy Sha has assaulted me by touching my breast and thereby outraged my modesty. Md. Rajab Ali, Bijoy Sha and Hira Sahani have abused us by saying "Sala Adibashir Baccha, Chhoto Jaat Kothakar, toder moto bokachoda oshikkhito lokeder amra 4-5 diner modhye toder bari theke mere vagiye dibo".

Therefore, I request you to kindly look into the matter and to take necessary legal action against (1) Md. Rajab Ali, S/o. Md. Tamijuddin@Abdul Majid, resident of Damra Gram, P.O. Gulma, P.S. Pradhannagar, Dist. Darjeeling (2) Bijoy Sha, S/o. Late Khelawan Sha, resident of Salbari, P.S. Pradhannagar, Dist. Darjeeling and (3) Sri. Hira Sahani, S/o. Madan Sahani, resident of Jhauguri, P.S. Matigara, Dist. Darjeeling. And for this kindness, I shall be obliged to you.
