In producing herewith one accused named Bapi Munda (21) S/O- Lt. Soma Munda of Baniakhari, Luchibagan, PS-Matigara, Dist- Darjeeling along with following articles under proper seizure

i) 12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 7.2 liters) and marked as "exhibit A" ii) One bottle Himalayan Gold 60 UP Country Spirit taken out from 'exhibit -A' as sample for examination and marked as "exhibit A-1"

I, ASI Tapan Das of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one named Bapi Munda (21) to the effect that today on 01/10/2021 at 18:10 hrs while performing evening patrolling duty, received a source information that one person named Bapi Munda is selling liquor in shop situated Baniakhari under Matigara Police Station without any valid license. Accordingly I informed the matter to the O/C PS and as per his kind direction myself along with C/1035 Santosh Rabidas, CV-387 Sukumar Barman had been to Baniakhari, under Matigara PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling and storing at his shop. Subsequently, I along with my force cordoned the residence and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Bapi Munda (21) S/O- Lt. Soma Munda of Baniakhari, Luchibagan, PS-Matigara, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18:40 hrs to 18:55 hrs at the spot and arrest issued memo of arrest at 18:58 hrs against him after informing the ground of arrest.


