Sir,

In producing herewith one namely Shyamal Barman (33) S/O Lalit Barman of Rananagar, P.S- Matigara, Dist-Darjeeling along with one seized vehicle bearing no- WB- 76- 8206 (Shaktiman) under proper seizure.


I, SI Md. Sanaullah of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the driver cum owner of vehicle no WB- 76- 8206 (Shaktiman) to the effect that today on 02.10.21 at 07:55 hrs while performing evening mobile duty vide MTG PS GDE No - 76 dated 02.10.21 along with force it was found that the above noted Shaktiman loaded with river bed materials was coming from Basbarighat side towards Matigara side. As such I detained the above noted vehicle at Basbarighat, Matigara being loaded with river bed materials driven by the above mentioned person. On being asked the driver of that vehicle disclosed his identity as noted above and being demanded he failed to produce any valid documents/papers for attempting to carry the river bed materials. On being further interrogation the driver of the vehicle bearing Regd. No- WB- 76- 8206 (Shaktiman) named namely Shyamal Barman (32) S/O Lalit Barman of Rananagar, P.S- Matigara, Dist-Darjeeling stated that he is involved in carrying of river bed materials by illegal means for his wrongful gain as per direction of his owner since last few months. Accordingly I seized the vehicle i.e., vehicle bearing Regd. No- WB- 76- 8206 (Shaktiman) who was trying to load river bed materials and subsequently arrested the driver named Shyamal Barman (33) S/O Lalit Barman of Rananagar, P.S- Matigara, Dist-Darjeeling. The whole process of seizure and arrest was made in between 12:35 hrs to 12:45 hrs.


Hence, I pray that a specific case may kindly be started against the driver namely Shyamal Barman (33) S/O Lalit Barman of Rananagar, P.S- Matigara, Dist-Darjeeling cum owner of above noted vehicle bearing no- WB- 76- 8206 (Shaktiman) who was trying to load river bed materials, under proper section of Law and arrange for its investigation.
