This is to inform you that there was a theft last night dated 30th September 2021 around 2:55 am in the morning. I saw in CCTV camera footage that a man with blue colour t-shirt and black capri pants (a little longer than half pant) entering from the boundary wall of our neighbour Mr Parthaj Sinha residing at Block A-19, Plot No. 5. He climbed on the wall and changed the direction of the camera so that his face was not visible. He entered into my room located in the first floor through the window which did not have a lock. He further went to the room facing bedroom located on the first floor, took a blue bedsheet and covered his face and body and climbed down the steps. He searched the kitchen and then he took my official briefcase and went to the ground floor guest room, where he searched it thoroughly.
