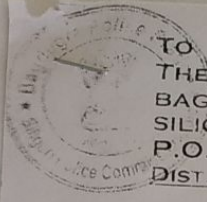

1. That on dated 14/04/2021 at about 8.00 A.M. in our working place Base Hospital, Bagdogra compound the above named Opposite parties physically assaulted me with cruelty as such I had been injured too (enclosed here with medical injury report and mobile video footage print-out copy xerox), after the said incident the said O/Ps had been lodged a completely false & manufactured storied F.I.R against me on dated 14/04/2021 in your P.S. in which a specific Case was started, bearing Bagdogra P.S. Case No. 147/2021, dated 15/04/2021, U/S 341/325/379 IPC and after get well I have released on bail before the learned A.C.J.M. Court, Siliguri on dated 26/04/2021.

2. That I further stating you that at the time of incident (14/04/2021 at about 8.00AM) I have in ROJA and discharged my Covid Pandemic Spl. Night duty from Base Hospital and the

said O/Ps had been intentionally physical assaulted with nail scratched (left side of my chest) in which I have been injured nail cut bleeding and quit my ROJA due to bleeding as per our muslim ritual but I have continued my Covid duties with injured condition till 18/04/2021 after that I felt sick as such I had been treated by Medical treatment on dated 19/04/2021 at Bagdogra P.H. Centre and continuing my duties till date.

3. That since the date of released on bail (26/04/2021) the above named O.Ps were rapidly tortured me mentally with extortion due to I belongs to Minority Communities ladies as such they ~~always neglected me else they were all ill-conditioned due no got an award (Best services award about Covid-19 Pandemic period from our Hospital Authority surrounding our Sahayika Group)~~ as such they are belongs to general communities has envy with me since that period to till date as such I am always feeling insecure in my work place & on road i.e. everywhere.

4. That within very few days the above named O/Ps had been mentally torturing me by uses filthy languages and behaved neglecting alongwith insulting or teasing me several times by orally or over mobile phones.

5. That the Opposite Party was highly influential in nature also narrow minded as such their (In way of my work place) every possibility for physical assault also probabilities of losses my life's or prestige by them or their appoint associates to myself by their rough harmful & criminal activities.

In the above I humbly request your goodness to be kind enough to look into the matter very seriously and to take strict, vigil and legal necessary action or actions against the O.P. for his illegal activities.

As such I the above named Petitioner as in duty bound shall ever remain grateful to you.
