I was returning to my home from cinema hall with my brother Pawan etc, in my car, we were passing through Shiv Mangal School, when I reached there I told my brother to stop car for Tarte, in Shiv Mangal School Lane, when I went for Tarte some of local boys were sitting there. I ask them is any tarte, one of them told me do it there, one of them who is wearing Black T-shirt starting using slangs on me, I argued for that then they all come and starting beating me, with hand & Belts, I was severely injured in my head & also bleed badly, After that all local persons come there & took me out from them, I went to Civil Hospital for treatment, I got 11 stitches in my head. So I Request you to look at this matter as soon as you can. And do Petroling in those areas.
