Sir,

In producing herewith one arrested accused persons namely Naba Kumar Roy (31) s/o Parimal roy of Ektiasal Haat, Near Navojyoti Club, PS Bhaktinagar Dist Jalpaiguri under proper memo of arrest along with seized articles viz:

1. 26 (Twenty Six) strips of Winspasmio Forte capsules composition with Tramadol hydrochloride-1P 50mg Acetaminophen 1P 325mg & Dicyclomine Hydrochloride 1P 10mg each strips containing 08 pieces of capsules [Total (26X08) = 208 pieces] packed and sealed and marked as "Exhibit-A" out of which two strips containing 2X08=16 pieces taken as sample packed, sealed and marked as "Exhibit-A1"

I beg to report that on 04.10.21 at around 18.50 Hrs I, received a secret source information that one Naba Kumar Roy of Ektiasal Bazaar has possessed huge numbers of blue coloured capsules inside the black colour plastic polythene bag and standing near Tiranga More, Shastrinagar under Bhaktinagar PS. From the information it came to learnt that the said person used to sell the contraband capsules without valid license to the local drug addicts of Siliguri for his wrongful gain. The said accused person may be apprehended if responded quickly. Accordingly, the matter was diarised in General Dairy vide Bhaktinagar PS GDE no- 237, Dated 04.10.21 and after informing you and without making further delay I along with ASI Rabin Lama, C/374 Debraj Biswas, CVF/935 Biplab Roy, CVF/014 Labanomoy Barman all of Bhaktinagar PS rushed to the spot. Also, informed Drug controller Jalpaiguri, over telephone to be present at the spot but he failed to appear on the spot.

On the way, I called two persons namely 1] Mukesh Roy s/o Raghbir Roy of Kholachand Fapri, Behind Loknath Mandir, P.O Salugara, PS Bhaktinagar, Dist. Jalpaiguri and (2) Rajiv Roy s/o Babu Roy of Tulsi Ghat, Prakash nagar, Ward no. 42. PS Bhaktinagar, Dist. Jalpaiguri s/o to stand as a witnesses during the search and seizure and arrest, if any. At 19.10 hrs, reached at Shastrinagar and contacted with the source and keeping the Govt vehicle at a distance. All the team took Toto from there and started proceeding towards Tiranga More where the accused person was standing who was waiting for his designed customer. As shown by the source, we cordoned the area in presence of the witnesses and managed to apprehend one

person and disclosed my identity and accompanied team as police personnel. On being asked, the person disclosed his identity, as Naba Kumar Roy (31) s/o Parimal roy of Ektiasal Haat, Near Navojyoti Club, PS Bhaktinagar Dist Jalpaiguri. Then, we conducted search of his person and recovered 26 (Twenty Six) strips of Winspasma Forte capsules composition with Tramadol hydrochloride-1P 50mg Aetaminophen 1P 325mg & Dicyclomine Hydrochloride 1P 10mg each strips containing 08 pieces of capsules [Total (26X08) = 208 pieces] which was kept in black polythene bag from his possession.

Further, on demand, he failed to produce any valid papers or documents in support of such possession of illegal capsules. Further, he admitted to have procured the said recovered drugs illegally for consuming them and peddling them to the drug addicts without any prescription.

On interrogation, the apprehended person admitted that he has possessed the above noted recovered articles to sell to his designed customer who he was waiting for. He also stated that, he has been doing this illegal business since after lockdown to run his family during the Covid-19 pandemic. His statement arose that there is strong reason to believe that he has procured the same illegally for his clandestine disposal. Accordingly, after observing all the formalities, I, seized, packed and labelled all the recovered articles under proper seizure list and label duly signed by the witnesses and acknowledged by the accused persons and also, arrested the apprehended above noted accused person u/s 41 Cr.P.C. All the formalities of seizure and arrest took place in between 20.05 Hrs to 20.35 Hrs.

Under the above circumstances, I pray before your kind end to start a specific case against Naba Kumar Roy (31) s/o Parimal roy of Ektiasal Haat, Near Navojyoti Club, PS Bhaktinagar Dist Jalpaiguri under proper sections of law and arrange for its proper investigation.
