I, Sumit Mahato (20) s/o Sri Lalpari Mahato, resident of Dangipara (Near Dr. Panna sweets), Ward No-6 SMC, P.O. & P.S. Siliguri, Distt - Dajeebry, beg to inform you that on 02-10-2021, at about 00:24 hrs, I received a call from, one of my familiar person, namely, Pankaj Sth s/o Raju Sth of Kurethi Mohalla (Near Dr. Rajendra Prasad High school) Ward No-6 SMC, P.O. & P.S. Siliguri, Distt - Dajeebry, to come at Dangipara area, and when I reached opposite, my fitness Puchy Gym at Vivekananda Road, at about 00:35 hrs, driving my ^{scoter} motorcycle bearing Regt. No. WB-74-BB-9315 (Suzuki Access Scooter) the said Pankaj Sth, intentionally dashed me & my scooter, driving his Blue colour Polo (Volkswagen) Car, without any number plate, badly and injured me grievously and tried to kill me, on the direction of the passenger of his car namely (1) Rohit Kanti s/o Not known of Central colony Gate Bazar, P.S. - NTP, Distt - Jalpaiguri, and my said scooter also damaged badly & I fell on the ground, then the both said person came out of the said car and started beating me with fist and glass, and also my friend namely, Sunny Khan (24) s/o Mehanna Khat, resident of Red light area, Vivekananda Road, Khalpara Ward No-7 SMC, P.O. Siliguri Bazar, P.S. Siliguri, Distt - Dajeebry, immediately shifted me to Siliguri Distt. Hospital and I treated myself there.

Sir, the above named alleged persons, (1) Pankaj Sth & (2) Rohit Kanti noted are very desperate & dangerous in nature and they have threatened me to kill any how. So, please take necessary actions against them.
