Sub:- Written Complaint for FIR against theft and unlawful dismantling of our Mobile Tower & other ancillary equipments thereof by our Landlord namely Mr. Swapan Sarkar, and Mr. Sourav Sarkar, son of Mr. Swapan Sarkar of valuable Materials from our Telecom Site located at the terrace of the Premises of Mr. Swapan Sarkar at Holding No. 127/306/266, within Ward No. 10, Siliguri Municipal Corporation, at Mahakalpally, Siliguri, within Panitanki Town Out Post within P.S. Siliguri, West Bengal.

Respected Sir,

Most respectfully, I, Sri Anup Kumar Saha, son of Late Akul Chandra Saha, aged about 39 years, working as the Manager, Law & Order with GTL Infrastructure Limited having its Circle Office at 'Shaila Tower', 7<sup>th</sup> Floor, Plot No. J1/16, Block - EP & GP, Sector- V, P.S. Electronic Complex, Kolkata- 700091, hereby would like to inform you that:-

1. That the GTL Infrastructure Limited is one of the leading Passive Telecom Infrastructure Provider of the country. We provide the same, viz. the Tower and its allied infrastructures by installation and maintenance of the Telecom Towers along with required equipments to the Licensed Telecom Operators of the Country.

2. We have a Telecom Site [Roof Top Tower] at the terrace of building of Mr. Swapan Sarkar at Holding No. 127/306/266, within Ward No. 10, Siliguri Municipal Corporation, at Mahakalpally, Siliguri, comprised in Plot Nos. 702, 703, Khatian No. 153, J.L. No. 110 (88), Pargana- Baikunthapur, within Mouza- Siliguri, P.S. Siliguri, West Bengal as installed by our predecessor -of- business which is situated with your local limits of jurisdiction. And the said Tower is a very important one for the Operator namely 'Reliance Jio'. That even after the expiry of the Principal Agreement dated 16<sup>th</sup> May, 2005, on and/or up to 15<sup>th</sup> May, 2015, i.e. till the said tower was forcefully shut down by the aforementioned two accused persons, we had paid the said Landlord up to 30<sup>th</sup> March, 2015 with an

intention to renew the said contract as the said Tower was working for wireless telecommunication services.

3. However on 22<sup>nd</sup> May, 2021 initially when our representative reached at the site for inspection works there it was found that the said entire Tower along with its all equipments having an worth value of Rs. 11,88,017.04/- has been/ have been dismantled stolen from the said site unlawfully causing our company an irreparable loss and injury. That to get ensured of the said loss we have sent our representative there at the site again on 24<sup>th</sup> May, 2021, but due to on going lockdown / restrictions imposed by the State Govt., we could not reach at your Police Station physically to lodge a police complaint initially. And finally this complainant too visited the said site on last 30<sup>th</sup> October, 2021, but was refused to enter into the said site by the said Landlord and his family.
4. It is to be noted that the said Telecom Tower structure and its ancillary accessories are purely movable property and can be dismantled and/or disassembled in part and can be moved out easily. This unlawful act was committed by the said accused persons to cause us total deprivation of our said valuable movable property which was owned and possessed by our company caused with an intention to cause wrongful gain by our Landlord aided by his family and miscreants committed without our consent with his intention to wrongful gain.
5. That the aforesaid theft of the valuable Tower and its materials has amounted a serious offence against us as well as public at large as the said Telecom Tower has been working as the 'Public Utility Devices'. The details of the material which was stolen from our site is mentioned below in the annexure-A.

Hence, in this context, I, the abovenamed complainant working as the Manager, Law & Order hereby for and on behalf of GTL Infrastructure Limited request you to take cognizance of this complaint and to take the necessary action against the said criminal act committed by said Mr. Swapan Kumar Sarkar and his son Mr. Sourav Sarkar for the ends of justice.

Humbly request you to treat this Complaint as the F.I.R. and to initiate the required investigation of the said theft from our telecom site as mentioned above.
