With benign submission I SI Diptajit Dhar S/O. Rabindra Nath Dhar presently serving under your kind disposal producing herewith one arrested accused person namely Narayan Chandra Saha (M/70) S/O. Lt. Nabadwip Chander Saha of House No. 29864, Jibananda Das Sarani, Rabindra Nagar Ward No. 22, PS. Siliguri Dist. Darjeeling along with following articles viz:-

1. Ellis 1000 , Firehen Brand 28 (TWENTYEIGHT) piece. (Chain cracker)
2. Eswari fire work King Cobra 4800 (FOURTYEIGHT) Piece. (Kalipotka).
3. Devis Fun Maza 30 multi colored Shots 10 (TEN) piece
4. Cock Kaliswari made Joy 30, 03 (THREE) pieces.

In this regard I, SI. Diptajit Dhar of SLG PS. SPC do hereby lodge this written complaint against the above noted accused person and two other absconded namely 1) Subir Saha (38/M) S/O. Narayan Chandra Saha of House No. 29864, Jibananda Das Sarani, Rabindra Nagar Ward No. 22, PS. Siliguri Dist. Darjeeling and 2) Raju Saha (35/M) of House No. 29864, Jibananda Das Sarani, Rabindra Nagar Ward No. 22, PS. Siliguri Dist. Darjeeling to that effect that today on 03/10/2021 at 13.15 hrs while performing K-22 van duty in and around SLG P.S Jurisdiction near Rabindra Nagar area Vide SLG PS. GDE No. 115 Dt. 03/10/2021, that time received a source information that one person along with his two son hired a Godown at Suprabhat Apartment on Gadhadhar Sarani and stored huge number of illegal Firecracker which creates sound beyond government restricted decibel limit for selling the same in the open market illegally and for their wrongful gain violating the government order.

Accordingly I informed you and as per direction I along with officers and force CV/626 - Jayanta Singha and CV/513 - Rajib Barman and Special operation group of SPC arrived at the hired Godown also arranged two independent witnesses namely 1) Dilip Kumar Bandho padhay S/O. Lt. Satya Prasad bandhopadhay and 2) Souvanik Saha S/O. Lt. Satya Ranjan Saha both of residence of Suprabhat Apartment on Gadhadhar Sarani, near Nandi Grill, Ward No. 22, PS. Siliguri Dist. Darjeeling and, on seeing police team two persons managed to escape from the spot and we managed to stop one other named Narayan Chandra Saha, on search found huge quantities of fire crackers stored in his godown and selling the same to the local market illegally. I apprehended him in presence of witness and demanded him to produced valid papers or license in support of possessing and selling the huge quantities of fire crackers but he failed to produce any documents in support of above noted firecrackers. On further interrogation, he confessed that he had procured the fire





crackers illegally and selling the same in locality and Siliguri for his wrongful gain and hence endangered the life of common people also disobeying the direction of the Ld. High Court Kolkata. I accordingly, seized those firecrackers in presence of witnesses and after preparing proper seizure list duly signed by the witness and accused and arrested him after preparing proper Memo of Arrest. The whole process of raid, seizure and arrest took place in between 13.35 hrs to 13.50 hrs and arrested the accused at 13.55 hrs after narrating the ground of arrest.

I therefore pray before you that a specific case may kindly be initiated against arrested accused ) arrested accused person namely Narayan Chandra Saha (M/70) S/O. Lt. Nabadwip Chander Saha of House No. 29864, Jibananda Das Sarani, Rabindra Nagar Ward No. 22, PS. Siliguri Dist. Darjeeling and two other absconded person namely 1) Subir Saha (38/M) S/O. Narayan Chandra Saha of House No. 29864, Jibananda Das Sarani, Rabindra Nagar Ward No. 22, PS. Siliguri Dist. Darjeeling and 2) Raju Saha (35/M) of House No. 29864, Jibananda Das Sarani, Rabindra Nagar Ward No. 22, PS. Siliguri Dist. Darjeeling under proper section of law.
