Respected Sir,

With due respect I, **SRI SWAPAN SARKAR**, Son of Bhabesh Chandra Sarkar, Resident of Mahakal Pally, Ward No. 10 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint to the effect that I am the owner in possession of all that piece or parcel of land measuring 2 Katha 14 Chhatak and 21 Sq. Ft., appertaining to and forming part of Plot No. 702 and 703, recorded in Khatian No. 153, of Mouza - Siliguri, J.L. No. 110(88), Touzi No. 3(ja), within the Ward No. 10 of S.M.C., Siliguri under P.S. Siliguri, Dist. Darjeeling and I have acquired the same by virtue of a Deed of Gift executed on 31.05.2001, being Document No. I-478 for the year of 2001, and thereafter, I have constructed a two storied residential pucca building in and over the said land, being Identified as Holding No. 127/306/266, within Ward No. 10 of S.M.C., Siliguri. In the year of 2005, the Authorized Representatives of Dishnet Wireless Limited, a Company under the provision of Companies Act, 1956, having its registered address at Sterling Tower, 327, Annasalai, Teynampet, Chennai - 600006 came before me and approached me to provide a open space measuring about 500 Sq. Ft. at the opened terrace above the first floor of my property under certain terms and conditions for a period of 9 (nine) years lease period to which, I have agreed and accordingly, a Deed of Lease was executed in between myself and the Authorized Representative of Dishnet Wireless Limited for the purpose of enjoying the open terrace of the first floor measuring about 500 Sq. Ft. and in the said Deed of Lease, it is specifically mentioned that after completion of the lease period, they

will clear all the accessories from the leasehold property. Since the date of execution of lease to till the period of termination of lease, they have enjoyed the said leasehold property without having any sort of disturbance and their engaged men and representatives have frequently visited the leasehold property as per their desire without any sort of disturbance. After completion of lease period, I being the owner of the aforesaid property, have made several request to the representative and authorized persons for un-installation of the Telecom Equipments installed in my property and I have specifically mentioned and requested them that I am not ready to renew the said lease equipments as the condition of my building is deteriorating day by day and any untowards incident may take place as our area is a earth quick zone. Moreover, the neighboring people have also make protest for renewal of the said lease and requested me to un-installation of the Telecom Equipments from my property as untowards incident may took place and there is every possibilities to loss of human lives also. On 17.11.2014, by issuing a letter, the Authority of Chennai Network Infrastructure Limited informed me dissemble and/or withdrawal of the Equipments of the Telecom Service Operators from my Leasehold property but very surprisingly ever after issuing the letter, neither they came before me nor dissemble/withdrawal of the equipments from my leasehold property. Thereafter, on 02.06.2015, finding no other alternative, I have sent a letter for termination of the lease agreement and un-installation of Telecom Equipment from my property to the Principal Officer of Dishnet Wireless Limited. Thereafter, the Representative and Authorized persons of the company have dissemble and withdrawal all the equipments from my aforesaid property and after un-installation of the Telecom Equipments, I have constructed a Tin Shade (Trash) in order to protect my room. After un-installation of the Telecom Equipments from my leasehold property, recently, some unknown

persons have come to my residence and made a illegal demand of the dissemble equipments of the telecom service operators and also threatened me with dire consequences and when I told them that their Representative and the Authorized Persons have already dissemble and withdrawal of the equipments in the year of 2015 after termination of the lease deed and some of the articles are still lying in the terrace of the first floor and they can lifted those articles at any time and hearing the same, they became furious and started to put a illegal demand from me with an intention to extort money from me and also threatened me that if I failed to pay the said demand, they will lodge a false complaint against me and my son and put us behind the Iron Bar and in this way, they are trying to blackmailing me. I can identify those persons if they produced before me. Sir, I am a Retired Government Employee, aged about 73 years, and after receiving such type of threatening from them, I have been passing my life with extreme fear and anxiety. I have already intimated the said facts before the Commissioner of Police, Siliguri Police Commissionerate on 01.10.2021.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal steps against the above miscreants as per the provision of law and obliged thereby.
