Respected Sir,

I, Sri Bapi Mohanta, s/o. Sri. Dilip Mohanta,
resident of Rabindrasarani, P.O. Kadamtala, P.S. Matigara Dist. Darjeeling, Pin - 734011 beg to state as follows:-

" That on 17th September 2021 at about 10 p.m., I am in puja Mondop of my friend named Narauttam Debnath and celebrating puja and having prasad with all my friends. At about 10.30 p.m. while I am ready to return home, I am just started walking about 10 to 15 step, suddenly one person came with bike and stop me and tried to struck on my back and started to assault with filthy languages. When I saw him in light I recognised that his name was ~~Dilip~~ Dilip Kumar Saha s/o. father named not known resident of vill- Rabindrasarani, P.O. Kadamtala P.S. Matigara Dist:- Darjeeling. When I give objection for his activity, he started to beaten me with kick and blows on my chest and also kick his bike on my body and I am fallen in earthen ground. All my friends and others save me and he run away with his bike. Later on I found my purse having Rs. 2150 (Two thousand one hundred fifty) only with Aadhar card and pan card within the purse was missing from my pocket. Next date he want to settled the matter mutually in front of my friends. But today at about 5.45 p.m. he denied to settled the matter and will not return my purse and documents. And also threatened me he will take revenge. So I am afraid as I am poor man. So, I do hope that you would be kind enough to allow my prayer and investigate the matter and save my life -
