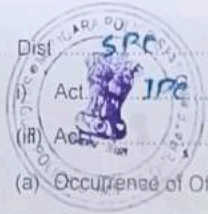


I Krishna Sarki, S/o Lt. Lal Bahadur Sarki, residence of Upper Bagdogra Hat, Upper Bagdogra, Bagdogra Dist:- Darjeeling wants to state I work as an marketing agent at Ghoshal Hardwares and Steel, Bagdogra that today around 12:30 P:M for my regular visits to the market I was going towards Alshiya More, near B.S.F Camp then all of sudden person's named Kundan Sah, Suraj Chhetri, Sudipto Halder and Sujit Saha all the workers of Kundan Hardwares, Airport More who also have a Hardware and Steel store called me near gossainpur and tried to threaten me for grievous hurt and safety of my life and even threatened me to not go to the Alshiya more construction site were our goods are being delivered at an regular interval as they want to deliver their goods in the said context we had some quarrel over the matter, but I overlooked them and started approaching towards my said location and they started following me as soon as I reached Alshiya more they stopped me and started pushing and physically assaulted me and started threaten me over again and again not to go to the construction site at Alshiya more, they even snatched Rs. 65,000 cash which was in a side bag which I collected from our customers whom we supplied goods at an regular interval and even snatched a bracelet of my owner's mother, worth Rs. 36,000 which I was taking for a repair work to the jewelry shop named Bidhan Jeweler's and Diamonds Pct Ltd. located at Siliguri. Both the cash and the gold chain was placed inside the side bag which they snatched from me. Looking at the situation and risk towards my life, I ran away from the place saving my life and the belongings which I was left over with.

That from last few days they have been trying to threaten me over the delivery of hardware goods at Alshiya more at the construction site. That they were at a clear intention of hurting me grievously and robbing my belongings.

Therefore, I request you to investigate this matter and take appropriate legal actions against them.


