It is bring to you attention that there was attempt of forcefully breaking of Onsite ATM Machine - ATM.ID ASIL00601111111 linked to our Patil Colony branch located at ward no: 47, Road no: 03 PO Patil Colony, Dist Darjeeling, West Bengal-between date 01-10-2021 to 04-10-2021. The same was noticed on 04-10-2021 at around 09.30 AM in the morning when the branch was opened after weekend holidays.

The miscreant had broken the lock of the outer door of the ATM machine and also the dispenser was also damaged. The cash vault was found intact and the cash has been tallied and no cash loss is reported.

The exact date and time of the incident could not be ascertained as the footage at night from 12:00 am to 9 am on both the days was not available.

Hence, we request you to lodge an in FIR against the unknown miscreant.
