

Sir,

With due respect I would like to inform you that recently my husband Nepal Chandra Debnath died on 20.03.2021 at the residence of my elder son Apu Debnath (M-8017497256) at 164/1 L.N. Road, Dum Dum Court under Dum Dum Police Station, Gorabazar, Kolkata-700065. My husband retired in the year 2006 from PWD Construction Board as Typist Grade-1. Since then myself, my husband and my youngest son Tapu Debnath was residing in our residence at M.M. Dutta Sarani by lane, Lake Town West, P.O. Siliguri Bazaar, Dist- Jalpaiguri, Pin-734005 and elder son was residing in the above noted address where my husband had invested a considerable amount for my elder son's residence in Kolkata. My elder son is working in Nursing Home Zenith at Belghoria, Kolkata as a Dialysis Technicien. Last year i.e. February 2020 my elder son took us myself & my husband to his Kolkata residence for our better treatment.

I am totally bed ridden due to spinal cord post operative problem since 2000 and my husband was a patient of neurologist disorder after stroke. Myself and my husband was almost bed ridden.

During his stay at Siliguri my elder son Apu Debnath took possession of all papers & Documents of all movable & immovable assts including gold ornaments approx 50 gms. (motor har, 3 finger rings, 2set ear rings, gold chain with gold button for Punjabi etc.)

Please note that said movable & immovable properties which he had taken to Calcutta when myself & my deceased husband moved to Kolkata in the month of February 2020.

All pension papers, land documents etc. were taken by my said elder son in his custody. My husband could not even sign on the cheque book which I used to sign as per the instruction of my said son. Pension savings bank account was joint account & I used to operate the same.

After the demise of my husband I came back Siliguri with my elder son for documentation of my family pension. I asked for the all documents but he denied to hand over the things possessed by him. He assisted me to open the pension account at UCO Bank Burdwan Road Branch as before. But suddenly opened another pension account at State Bank of India, S.F. Road Branch without my
