Sir,

With due respect, I am producing herewith the arrested accused person namely Sushil Sarkar (60 yrs) S/O Late Kalipada Sarkar of Rabindra Nagar Colony, Ward No 02, PS- Kotwali, Dist.- Jalpaiguri presently residing at the house of one Bhetu of Bhaktinagar, Ward No-35, PS- NJP, Dist - Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 26 (Twenty Six) bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle.
2. 06 (Six) bottles of 60 up Himalayan Gold Country Spirit containing 300 ml in each bottle.

1. SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 01.10.21 at 12.15 hrs I received a secret source information that one person namely Sushil Sarkar is selling ID liquor illegally at his shop at Hotel Line, NJP, PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 22 dated 01.10.21 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, VP/08 Laxman all of NJP PS, SPC left for Hotel Line, NJP to work out the information in hand. At about 12.45 hrs we arrived at the shop of Sushil Sarkar of Hotel Line, NJP PS- NJP, Dist - Jalpaiguri and being shown and identified by the source I held raid at the shop of Sushil Sarkar at Hotel Line, NJP and managed to apprehended one person. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between hrs 13.15 to 13.45 hrs on 01.10.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sushil Sarkar (60 yrs) S/O Late Kalipada Sarkar of Rabindra Nagar Colony, Ward No-02, PS- Kotwali, Dist.- Jalpaiguri presently residing at the house of one Bhetu of Bhaktinagar, Ward No-35, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
