Subject : Complaint for harassment.

Respected Sir/Madam,

I am Kritika Gupta, daughter of Madhukar Prasad Gupta, age - 22, a resident of Mg Marg New Market House no 19, Gangtok Sikkim who also resides at Ward no 35 NJP Main Road, Bhaktinagar, Dist Jalpaiguri, is writing this letter to file a complaint about the harassment I have been facing.

This is to inform you that I was harassed and threatened from (May - Sept 2021) on regular basis by Geeta Gupta wife of Shashikant Gupta (Shashikant Gupta is my Father's elder brother) their children (Anupam Kr Gupta, Rupam Gupta and Vishakha Gupta) and Ramavad Chauhan (who is an outsider) residing in Ward no 35 NJP Main Road, Bhaktinagar, Dist Jalpaiguri currently I having to live in the same house as it equally belongs to my father too is unsafe for me and is becoming a matter of concern for me. I request you to lodge a complaint against the mentioned people. I am harassed but during the month of Sept things became more worse with illegal electricity cut (since 8/09/2021) and her daughter Vishakha Gupta, threatens my family stating she will send us behind the bars if I take any action against their deed as she bring people to threatened me and she herself does that too, I was also molested for years from the age of 6 to 11 years old by Rupam Gupta (Son of Geeta Gupta) I was threatened to not speak about it. A Lot of men are welcomed in that house which makes me even more unsafe to live there. During the course of lockdown (May - Sept) was continuously starved and harassed by the man living illegally with Mrs Geeta Gupta named Ramavad Chauhan (mentioned above) who isn't a part of our family member. I am body shamed and character assassinate. They put false allegations on me to be on the safer side to make sure I don't fight for the wrongs. Stating the issue of (11/08/2021) I was robbed in my own house where I lost all my necessary documents and cash, I filed an FIR for the same in NJP Police Station and when I go to my kitchen to do the house chores my items and cash are always missing from my room. I recently lost my mother's chain as well (ie 24/09/2021) before I was coming back to Gangtok to look after my mother as she is unwell I came home on (26/09/2021). For years they have harassed my family for money for the maintenance of that house.

Its about my safety and I have tried reaching out to the authorities but I was put under alot of pressure and was threatened by them to not take it to the matter to the police. It just got worse with time. I regret the situation but can't ignore it. I suffered for many years alone which mentally have destroyed me because I was forced to commit self harm and blame it on my family. I am to visit a psychiatrist at my earliest for the sake of my mental health.

It is proving to be a tough period for me and therefore, I request you to kindly help me with the same. I believe I would get to hear from your side at the earliest.
