With due respect, I am producing herewith the arrested accused persons namely (i) Subhankar Saha (32 yrs) S/O Late Shyamal Saha of Hakimpara, PS- Siliguri, Dist. Darjeeling (ii) Sourav Debnath (21 yrs) S/O Paban Debnath of Sahid Colony, PS- N.J.P, Dist- Jalpaiguri (iii) Biswajit Paul (34 yrs) S/O late Ajit Paul of Atul Prasad Sarani, Hakimpara, PS- Siliguri, Dist.- Darjeeling (iv) Miraj Ali (23 yrs) S/O Imtiaz Ali of Sahid Colony, PS- N.J.P, Dist. Jalpaiguri and the following articles under seizure :-

1. One white colour small vehicle (Tata Nano) displaying number plate WB/70/C/3077.
2. One sharp cutting knife from the possession of accused Subhankar Saha (32 yrs) S/O late Shyamal Saha of Hakimpara, PS- Siliguri, Dist.- Darjeeling.
3. One iron made sharp cutting weapons called as Bhojali from the possession accused Sourav Debnath.
4. One sharp cutting knife and one plastic made charger torch light and from the possession of accused Biswajit Paul.
5. One iron made Hasua and one iron made sabol from the possession of accused Miraj Ali

1. ASI Sajal Das of N.J.P PS, Siliguri Police Commissionerate beg to state that on 01.10.21 at 21.45 hrs I received a secret source information that a gang of miscreants come to Cannel Road near Nawapara More under PS- N.J.P, Dist.- Jalpaiguri by a Nano vehicle with deadly weapons and assembled there and making preparation for committing dacoity at Fulbari area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide N.J.P PS GDE No 42 dated 01.10.21. As per kind order and direction of my superior officer myself along with ASI Khagen Barman, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/300 Bisawajit Roy, and CV/824 Niru Yadav left for Cannel Road to work out the information in hand. I also informed the fact to night RT Van officer SI Shyamal Dutta Roy and requested him to come to Cannel road to accompany with us. At about 22.25 hrs on 01.10.21 we reached at Cannel Road under PS- N.J.P, Dist.- Jalpaiguri and started to searching the said vehicle. After a few time SI Shyamal Dutta Roy along with force came to Cannel Road and accompany with us. At about 22.45 hrs as indicated by the source we noticed that one white colour small vehicle is standing in a dark place at opposite Nawapara More. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully and from a considerable distance we found 6/7 persons assembled in a dark place and they were whispering in a very low voice. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted.
