

Sub: - F.I.R

In producing herewith one (01) arrested accused person namely Sujite Prasad (27) S/O Lt. Bharad Prasad of Shivnagar, Darjeeling More, PS. Pradhannagar, Dist. Darjeeling, along with the following articles

a) One chocolate colour school bag styled as 'Puma' containing 32 (thirty two) bottles of "Cefrex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHU 0232, Mfg. Date: 02/2021. Exp. Date: 01/2023 which was - seized from exclusive and conscious possession of above noted Sujite Prasad and marked as "Exhibit- A".

b) One (01) bottle of "Cefrex" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for

examination and marked as "Exhibit A-1"

c) Cash rupees 7,500/- [Rupees Seven thousand and five hundred only] Indian Currency Note in the following denomination;

Rs. 500 X = 11 = 5,500/-Rs. 100 X = 20 = 2,000/-

Total = 7,500/- [Rupees Seven thousand and five hundred only] [kept inside the right pocket of trouser].

I, SI Basudeb Guha (49), S/O- Lt. Badal Ch. Guha of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Sujite Prasad (27) S/O Lt. Bharad Prasad of Shivnagar, Darjeeling More, PS. Pradhannagar, Dist. Darjeeling to the effect that on 06.10.2021 at about 19:05 hrs I received a specific source input that one person possessing huge quantity of 'Codeine Phosphate' based drugs was standing at Goyel More near NBSTC Workshop under Matigara PS to sell the same to his designed customers. The matter was diarized in Matigara PS GDE No. 306, Dt. 06.10.2021 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with PSI Abhishek Theengh, PSI Newton Biswas, ASI Nitai Mandal, Const- 1035 Santosh Rabidas and Const- 986 Rajib Sarkar all of Matigara PS, SPC along with investigation kit left for Goyel More under Matigara PS by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 307, Dt. 06.10.2021 and M.C.C No- 374/2021 Date-06.10.2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Goyel More under Matigara PS I contacted two persons namely (1) Md. Azad (38), S/O- Md. Mehebub Ali and (2) Reeju Khan (39), S/O- Lt. Riaz Khan both of Tumbajote, P.O+PS- Matigara, Dist-Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which, they agreed. Thereafter, we along with above noted independent witnesses arrived at Goyel More near NBSTC Workshop under PS- Matigara at 19.45 hrs and subsequently, being pointed by my source, detained 01 (one) person standing near Goyel More and he was carrying one school bag under his exclusive and conscious possession. Thereafter, we disclosed our identity and the information in hand stated him that he as well as the bag under his possession will be searched for the purpose. And, I also gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Goyel More near NBSTC Workshop under Matigara PS to remain present and to supervise the search and seizure.

Accordingly at 20.35 hrs Shri Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Goyel More under Matigara PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person namely Sujite Prasad following all formalities, keeping his decency and recovered the above noted articles of the accused person namely Sujite Prasad (27) S/O Lt. Bharad Prasad of Shivnagar, Darjeeling More, PS. Pradhannagar, Dist. Darjeeling.

It has been found from the bag under the exclusive and conscious possession of the above noused person records and conscious possession of the above noused person records. accused person namely Sujite Prasad containing 32 (thirty two) bottles of "Cefrex" cough syrup (cough syrup to 2.2 Kg) bottle containing 100 ml) containing 32 X 100 ml = 3200 ml i.e., equivalent to 3.2 Kg].

Further, on demand in presence of Shri Manabendu Sekhar Rakshit, Assistant Commissione Ce. Silipuri Police Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC detained paragraphs or explanation detained person namely Sujite Prasad failed to produce any valid documents/papers or explanation possessing of any little prescribed limit. possessing of such huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 32 (thirty two) bottles [containing 3200 ml i.e., equivalent to 3.2 Cetrer, Court 200 ml) which of "Cefrex" Cough Syrup [including 1 (one) bottle of "Cefrex" Cough Syrup (containing 100 ml) which taken renders. taken randomly from the mother packet for examination] from the exclusive and conscious possessic above noted accused person namely Sujite Prasad at the spot at Goyel More near NBSTC Workshop u PS- Matigara, Dist- Darjeeling under proper seizure list in presence of independent witnesses and Manabendy, Solds. Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate des for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by accused person namely Sujite Prasad.

Subsequently, I labelled and sealed the seized articles in presence of Shri Manabendu Sekhar Rak Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Property Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Property Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Property Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Property Commissioner of Police, Siliguri Police Commissioner of Police Magistrate, SPC and independent witnesses and the accused person namely Sujite Prasad. The w process of seizure was made in between 20.45 hrs to 21.15 hrs.

Being further interrogated, the apprehend person namely Sujite Prasad admitted in presence of Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate det for acting as Special Executive Magistrate of SPC and independent witnesses that he has procured 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to designed customer for his personal gain by illegal means. He also disclosed that he has been deali this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few month his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the acc person namely Sujite Prasad is involved in procuring and selling 'Codeine Phosphate' based drugs ille contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Sujite Prasad after observing all forma and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law kindly be started against the accused person namely Sujite Prasad (27) S/O Lt. Bharad Prasa Shivnagar, Darjeeling More, PS. Pradhannagar, Dist. Darjeeling and arrange for its investigation.
