Sir,  
On the 5th/10/21 around 7pm,  
at Jay Service Petrol Pump, Bhaktinagar,  
a truck No WB-73 B 8667, hit my  
car, Datsun Go - No: WB 74 AJ 1638,  
while <sup>being moving</sup> out of the station. Our car  
had been parked on the left side  
of the petrol pump and as we  
just started the vehicle to exit,  
the truck rammed into our car.  
The truck which was being driven rashly  
and negligently and dragged our  
car. It has been damaged  
on the driver's side and the  
bonnet too. We are enclosing  
photos showing the damage.

The truck was driven by  
one Suril Kumar, DL No -  
SK 03 2018 0000193. We  
initially asked the driver to  
get down and got all the  
information from him. Later on

however, when the people at the petrol pump asked us to move our vehicle and talk aside, the driver tried to flee the scene.

When the owner, Deepak Goyal was contacted, over the phone, he was rude and unco-operative and told us to do whatever we wanted. We told him that we would go to the police station and to meet us there. After a long wait for Mr. Goyal, we met the I.C., Bhaktinagar P.S. and related the incident. I.C. Sir called the driver and questioned him. He also examined our damaged vehicle along with our mechanic. The mechanic has estimated our damages at approximately ₹25,000.

When Deepak Goyal was called to the thana, he asked for time to come the next day. We agreed to meet him the next day. i.e. today, the 6th of Oct '21.

We could not come to an agreement since the owner refuses to pay us any damages. The said truck owner is Deepak Goyal, S/O N.M. Goyal, resident of Salyajit Roy Sarani, Tiyoti Nagar, Seroke Road, W No 41, Siliguri Municipal
